Additional Comments:	The initial Contract amount was not to exceed \$1,630,000. Amendment No. 1 increased the Contract by an amount not to exceed \$8,440,000. Amendment No. 2 decreased the Contract by an amount not to exceed \$3,980,000. Amendment No. 3 decreased the Contract by an amount not to exceed \$2,445,000. Amendment No. 4 will increase the Contract by an amount not to exceed \$360,000 for a new total Contract amount not to exceed \$4,005,000, should all renewal options be exercised.		

**BACKGROUND:**

On February 15, 2022, the Board of County Commissioners (Board) approved the award of CBE No. 606071-21 to Liberty Wellness Outpatient Counseling Center, LLC (NBE) in the amount not to exceed \$1,630,000 for basic needs support for Clark County visitors, community residents and families who have been affected by Covid-19.

The following are the pertinent provisions of the Contract:

- The term of the Contract was from November 1, 2021 through June 30, 2022.
- Included the County's option to terminate for cause, convenience or default and suspend the Contract with advanced written notice.

Amendment No. 1 added 4, one-year renewal options to allow for the continuation of services.

Amendment No. 2 reduced services from two (2) buildings to one (1).

Amendment No. 3 changed the Contract title to better describe the population being served, replaced the Scope of Work in its entirety and reduced the number of renewal options to 2, one-year.

Approval of Amendment No. 4 will extend the Contract for an additional 6 months, on a month-to-month basis. The attached Amendment No. 4 document details the modifications and costs involved.

Liberty Wellness Outpatient Counseling Center, LLC currently holds a Clark County Business License.
