

**SUPPLEMENTAL NO. 3 TO THE PROFESSIONAL ENGINEERING SERVICES  
CONTRACT FOR CACTUS AVENUE  
FROM FORT APACHE ROAD TO BUFFALO DRIVE**

THIS Supplemental No. 3 to the Contract, made and entered into this 20<sup>th</sup> day of September, 2022, between CLARK COUNTY, NEVADA, a political subdivision of the State of Nevada, hereinafter referred to as "COUNTY", and CA GROUP, INC., a corporation authorized to do business under the laws of the State of Nevada, hereinafter referred to as "ENGINEER". The COUNTY and ENGINEER may herein be referred individually as "Party" or collectively as "Parties".

**W I T N E S S E T H**

**WHEREAS**, on October 15, 2019, the COUNTY and the ENGINEER entered into a contract for professional engineering services for design services for Cactus Avenue, Fort Apache Road to Buffalo Drive; and,

**WHEREAS**, the COUNTY has previously authorized Special Services for the design of raised medians, additional subsurface utility exploration and stormdrain modifications, additional design to adjust the roadway cross section for Cactus Avenue, Fort Apache Road to Buffalo Drive; and,

**WHEREAS**, on April 20, 2021, the COUNTY authorized Supplemental No. 1, increasing funding by \$110,360.00, (\$52,525.00 in Basic Services and \$57,835.00 in Special Services), to revise the design to accommodate Bureau of Land Management (BLM) easement limitations, upsize a proposed stormdrain, provide post design services; and,

**WHEREAS**, on March 1, 2022, the COUNTY authorized Supplemental No. 2, increasing funding by \$51,716.00 in Special Services, to revise the design to widen Buffalo Drive south of Cactus Avenue, prepare a US Army Corps of Engineers Section 404 permit, and revise design documents to complete all Basic Services and authorized Special Services; and,

**WHEREAS**, the COUNTY desires to extend the time of performance which is required to complete all Basic Services and authorized Special Services.

**NOW, THEREFORE**, for and in consideration of the premises and mutual covenants herein contained, it is agreed as follows:

#### **ARTICLE IV: TIME OF PERFORMANCE**

##### **4.01 Time of Performance**

**Replace the paragraph at the end of 4.01 Time of Performance with the following:**

Except as otherwise set forth above, the ENGINEER shall complete all Basic Services and authorized Special Services within the completion times prior to July 31, 2024, unless such date is amended by the COUNTY.

The remainder of the Professional Engineering Services Contract dated October 15, 2019, Supplemental No. 1 Contract dated January 6, 2022, and Supplemental No. 2 Contract dated March 1, 2022, remains unchanged.
