Additional Comments:	The initial Contract amount was not to exceed \$28,000,000. Amendment No. 1 increased the Contract by an amount not to exceed \$7,487,172. Amendment No. 2 increased the Contract by an amount not to exceed \$8,442,000. Amendment No. 3 increased the Contract by an amount not to exceed \$6,174,552. Amendment No. 4 increased the Contract by an amount not to exceed \$37,809,000. Amendment No. 5 increased the Contract by an amount not to exceed \$15,092,750. Amendment No. 6 increased the Contract by an amount not to exceed \$18,962,531.10. Amendment No. 7 will increase the Contract by an amount not to exceed \$4,740,632.78, for a new total Contract amount not to exceed \$126,708,637.88 should all renewal options be exercised.

On September 20, 2016, the Board of County Commissioners (Board) approved the Master Contract for RFQ 604131-16 for Foster Care Services in the aggregate amount of \$28,000,000.

The following are the pertinent provisions of the Contract:

- The term of the Contract was from date of award through September 20, 2017 and included the option to renew for 3, one-year periods. There are no renewal option(s) remaining.
- Included the County's option to terminate for cause, convenience or default and suspend the Contract with advanced written notice.

Amendment No. 1 updated the daily rates for each category of Foster Care Services.

Amendment No. 2 increased the type of services, added the pricing associated with the services and included Contract services eligible for Federal Title IV-E funding reimbursement.

Amendment No. 3 reduced the type of services and revised the pricing.

Amendment No. 4 extended the term of the Contract through December 31, 2022 and replaced Exhibit D, Agency Foster Care Rate Schedule.

Amendment No. 5 extended the term of the Contract through December 31, 2023.

Amendment No. 6 extended the term of the Contract through December 31, 2024.

Approval of Amendment No. 7 will extend the term of the Contract through March 31, 2025. The attached Amendment No. 7 document details the modifications involved.
