Additionally, responsible for coordination of emergency response efforts with community partners in law enforcement, EMS, rural volunteer firefighters, and utility companies. Assistance in maintenance and upkeep of fire equipment, apparatus, and facilities in rural stations. Provide community education and engagement in issues relevant to the fire service such as fire safety and risk reduction. Currently assigned to lead the Rural Service Division, Wildland Protection Program, Southern Nevada Incident Management Team, and other duties as assigned. Previous responsibilities included the Fire Department liaison to the Southern Nevada Counter Terrorism Center and LVMPDs MACTAC section, providing training and awareness in catastrophic incident response, unified police/fire operations, and threats to Homeland Security.
