When Crown Point Apartments raised my rent in 2021, I took several residents to the Advisory Board to see if there was something they could do about the problem. Crown Point was illegally charging us, along with indiscriminately raising our rents. We were told by the board there was nothing they could do about it. I have been to many board meetings since then to see if there was any progress in dealing with the Apartment Complexes in town, along with other changes that benefit the residents of Laughlin. It appears that most meetings there is no agenda and no progress. I have seen several people come to the meetings and request things to be done with little or no success. I am for affordable housing and wish to continue to press this issue with the town, the county, and the state. I spent 10 years in Administration in the California Army National Guard and understand the chain of command and how to get things done through relationships along the chain. I feel my experience can bring a new perspective to the board.

I am currently not on any board.

Why are you interested in becoming a member of your TAB or CAC?

I am and always been a worker. I have lived in Los Angeles and came from a Middle Class home. I would like to represent the interests of the workers, the Veterans, the disabled and the homeless. I would like to be a younger voice among a board of mostly seniors. There are many ideas that I have to bring Laughlin into the 21st Century, not just keep the same status quo. One example is how the town has no solution to our intersection in front of the Library. People have been hit trying to cross the road here as it is a steep incline and people tend to speed. The town has sent in for a study to be done to maybe put a crosswalk. This, they said, will take years. My suggestion is to paint the road with colorful designs before the intersection. This has been done in other cities with great success. This is just one idea of many where we need to think outside the box these days as there is not a lot of money to work with. I would love to serve the town of Laughlin with empathy, pride and integrity.

Letter of Interest:

My name is Bradley Beck. I am from California - I spent most of my life there and moved to Laughlin in 2019 when it became too expensive to live there. Since moving to Laughlin, I have seen little to no changes for the better of the residents. I have attended many Board Meetings and have seen people request changes that seem to never take place.

I spent 10 honorable years in the California Army National Guard working full-time, got a degree with honors from Cal State Northridge in Geology and worked in the oil industry as a logging Geologist.

My rent was raised almost 100% in May of 2021 and I tried to bring this and other complaints to the town and after bringing several residents to the board with me, we still got no results as the board told us there was nothing they could do about a business operating in their town. The Constable also informed us that there was also nothing he could do about the raising of rent and false charges to our rent.

I have attended several meetings since then but never have seen improvements in the care for Veterans, the homeless, the elderly by maybe getting a pharmacy rather than going across the river for medication, along with no talk about affordable housing. These are important issues facing Laughlin but get no voice in our Advisory Board. The only thing I have seen them do is to authorize a new gun store in town.

The reason there is a seat on the board is because one of the members didn't go to the Secretary of State to declare his running for office. I wish to take his place on the board. They all have said they are elected to support Laughlin remaining a Township. I wish to be the other voice for the town. I wish to represent the Veterans, the disabled, the mentally ill, the homeless and the workers, while the rest of the board can represent the interests of the businesses and the Casinos.

My intentions for the Laughlin Town Advisory Board Position are to honorably serve the interests of the citizens of Laughlin with pride, integrity and empathy towards those who need assistance, not just the interests of the businesses and homeowners. Thank you for your time.
