AMENDMENT I TO AGREEMENT FOR DESIGN, RENOVATION AND DONATION OF DOG PARK IMPROVEMENTS AT SILVERADO RANCH PARK

This AMENDMENT I TO AGREEMENT FOR DESIGN, RENOVATION AND DONATION OF DOG PARK IMPROVEMENTS AT SILVERADO RANCH ("Amendment I") is entered into and is effective as of this ____ day of _____ 2022 ("Effective Date"), by CLARK COUNTY, a political subdivision of the State of Nevada ("County"), and DIACON, LLC, a Nevada limited liability company ("Donator") (County and Donator may individually be referred to as a "Party" and collectively as the "Parties").

RECITALS:

WHEREAS, on September 21, 2021, the County and Donator entered into an Agreement for Design, Renovation, and Donation of Dog Park Improvements at Silverado Ranch Park ("Agreement"); and

WHEREAS, there has been supply chain issues resulting in delays to the completion of the Project (As defined in the Agreement); and

WHEREAS, the County and Donator desire to extend the completion deadline of the Project.

NOW, THEREFORE, in consideration of the promises and of the mutual covenants herein contained, it is agreed as follows:

- Donator shall substantially complete the Project no later than June 30th, 2022, and release the park to the public for use.
- 2. Notwithstanding the above, Donator shall have until August 31st, 2022, to complete remaining punch list work, install signage and/or other monument improvements to effectuate the naming of the Project authorized in Section 6 of the Agreement. Design of such signage or monument shall be subject to prior approval by the County by and through the Director of Real Property Management or their designee to ensure aesthetic consistency with other County parks and improvements.
- 3. Any provision of the Agreement not amended or deleted by this Amendment I shall remain in full force and effect.
