Good morning, Mr. Schiller.

#### **KEVIN SCHILLER**

Good morning, Chairman and Commissioners. Your first item is to present a proclamation to Virgin Atlantic in recognition of their 25 years of service to Las Vegas. Commissioner Gibson.

#### JIM GIBSON

Thank you. I'd like to invite Andrew Morley, the airport manager here at Reid International, together with his duty managers who are accompanying him, and Ms. Vassiliadis to the front. And in the meantime, let's roll that video that we have.

(Video Presentation Begins)

This summer, Virgin Atlantic is celebrating a remarkable journey, 25 incredible years of non-stop service to Las Vegas. In June of 2000, Virgin arrived from London in style, becoming the first airline to offer direct service to Southern Nevada from across the pond. Its partnership with LAS (Harry Reid International Airport) truly opened the door to schedule transatlantic routes to Las Vegas.

We hope to be the gateway to the southwest for Europe.

Virgin was here for the grand opening of T-3 in 2012, and it was the first international carrier to arrive at the new terminal.

Welcome back.

Thank you very much. It's exciting to be here, I must admit.

In 2021, the airline kicked off the highly anticipated return of transoceanic service to Las Vegas after a 20-month pandemic pause. Over the last 25 years, service has expanded to include daily flights from London, Heathrow, as well as three flights per week from Manchester.

And I couldn't be more proud of the amazing team we've got here in Las Vegas. We couldn't do it without them.

Cheers to Virgin Atlantic for its years of successful partnership in Las Vegas and to many more fabulous journeys ahead.

Yeah.

#### JIM GIBSON

Really happy to have you here with us today. Let me just say a few things, some of which were summarized, but Virgin Atlantic first took to the skies in 1984, taking off from London Gatwick with non-stop flights to Heathrow, Gatwick and Manchester, the second-largest transoceanic airline serving Harry Reid International Airport. On June 3, we celebrated the 25 anniversary of them operating here, first coming here. They're Britain's second-largest carrier with non-stop transatlantic flights from Heathrow including Las Vegas, New York, Orlando, the Caribbean, Delhi, and Johannesburg.

Thanks to the hugely successful joint venture with Delta, Air France, and KLM (Royal Dutch Airlines), we can seamlessly connect our customers to over 350 cities across North America, Europe, and the United Kingdom. This is a really important partner. Now, given all of the things that we read about visitation in the last months, we know how important international travel is to us and how down it is generally, and we appreciate very much the work that Virgin Atlantic has done to keep them coming and we want to celebrate with you and we present you with this proclamation today. We hope that you'll understand that our County Commission really does view a partnership with you through Rosemary's office and Reid

International Airport. So, thank you very much for being here. Why don't you take a minute, introduce your duty managers and just take a moment and help us understand your perspectives?

#### ANDREW MORLEY

Thank you, Commissioner Gibson, and Commissioners, ladies and gentlemen, thank you very much. It's an honor to be here today to celebrate our 25 years in Las Vegas. I've been here for the past eight years leading the team. I've got Jocel here on my far right and Renee also and they really run the operation and deliver what it is that really makes Virgin Atlantic different for our customers and that is pushing the limits being a real pioneering kind of operation. So, really trying to make things the best it can be, not just accepting second best, which is exactly what Richard Branson stood for when he started the airline back in 1984. So, we've had a great partnership with Rosemary and our team. We absolutely love working with the Clark County Department of Aviation. It's an incredible relationship and we're so grateful for this wonderful partnership. So, thank you everybody.

I am an immigrant in this state due to the fact I'm in a backwards world. I've been placed into a condition that causes illness and causes disaster. I have not received my workman's comp and I have not received my pension and I'm being placed outdoors to be a homeless victim, never to take care of my children. And you have taken my finances for yourself. The shelter is not trying to assist me because it does not address me. It's only for immigrants. I'm American citizen. I can't live here. I'm placed in Texas as Coleman County. I was injured in Las Vegas, Nevada under the condition of emergency arsenic lead poison that I have addressed you upon to receive. I want to know why I'm going through these conditions and why I have not improved and you have not called me, not even once.

#### TICK SEGERBLOM

#### RICHARD MANHATTAN

Good morning, Mr. Chair, Members of the Commission. My name is Richard Manhattan and I am here today to speak on Item 42, emerging issues. I am specifically here to request that this Board consider

protections for whistleblowers within the county. I have been a part of an unfortunate incident recently that has brought the lack of that protection to my attention and I would ask that this body instruct its staffs to consider instituting those types of protections both on the funding and the retaliation side in the county. #### JUSTIN JONES

I am sure Commissioner Becker's coming back, so Mr. Manager, if you want to go forward with the hearing?

#### **KEVIN SCHILLER**

Now, move to the public hearing section of your agenda. Item 32 is to conduct a public hearing to amend Clark County Code Title 8, Chapter 8.20, Section 8.20.020.150 regarding access and control of alcoholic liquors stocked in hotel rooms, private booths and viewing areas in a resort hotel movie theater, and private skyboxes; and providing for other matters properly related thereto.

Before you open the hearing, I need to read one correction. For the record, I'd like to read a correction on Item 32. Under your Public Hearing Agenda staff has the following changes to section one of the

proposed ordinance. Delete proposed subsection (c) and add an "and" after subsection (a), and add, or prevent access to, subsection (b). And make the same consistent change to subsections (e) on page three and four, and subsection D on page five, by adding or prevent access to. You should have a red line of these changes and there's copies available for the public also.

#### WILLIAM MCCURDY II

Thank you, Manager Schiller. Mr. Queano you have a presentation?

#### VINCENT QUEANO

Good morning, Mr. Chair, Members of the Commission. Vince Queano, Director of Business License. Although I don't have a formal presentation, I do have a copy of the proposed draft in case there's any questions, so we could be on the same page.

But an Individual Access License allows a licensee to stock hotel rooms and hotel room suites with alcoholic liquor under the control of the adult guests. An Individual Access License also allows resort hotel to stock cabinets and refrigerators with alcoholic liquor and private box, or private viewing area, in an arena or a movie theater. Sports and convention pavilion licensees are also eligible to obtain a Individual Access License for the purpose of stocking alcoholic liquor and private sky boxes in an arena.

The first part of the code covers hotels and resort hotels, and the second part of the code covers sports and convention pavilions. The requirement that alcoholic liquor must be stored in a locked or secured refrigerator or cabinet was removed as the requirement is unenforceable. We lack the resources to inspect every hotel room, hotel room suite, private sky boxes, or private viewing areas for compliance.

However, we did add the requirement that licensees must obtain a written acknowledgement and agreement to assume control of the alcoholic liquor and prevent consumption by minors. This is already a common practice among hotel, resort hotels, and sports and convention pavilions in Southern Nevada.

Licensees must also remove or prevent access to the alcoholic liquor if the adult guest declines to acknowledge and assume control of the alcoholic liquor and prevent consumption by minors.

So that completes my presentation and I'll be more than happy to answer any questions.

#### MARILYN K. KIRKPATRICK

Yes. I only have one thing. I feel like there's an echo and either I can't hear today, or it's all mumbled for me, but sorry. I just really wanted to thank Parks and Rec staff. As everybody knows, we all support a special needs pool party for all of the kids across the valley. This is our 12 year of doing it and our biggest year, we had a little over 350 families with special needs. So that's everything.

And I started this years ago at the state with the Desert Regional Center with the clients that are there that are autistic and they're maybe 40. And so, we expanded every year to allow more families to be able to come because they can play together, they can have their meltdowns. It's a very stimulating, fun event, but it wouldn't be so great if the lifeguards at Desert Breeze didn't take those extra measures to ensure that everybody has a safe and fun time. So, I just always like to point it out. We had a little group a little over almost 400 people show up this year, so it's just a great event. So, I want to thank the board for always supporting me on these little things.

#### TICK SEGERBLOM

Commissioner Jones?

#### JUSTIN JONES

Thank you, Mr. Chair. And I couldn't agree more that Desert Breeze is the best rec-room center. I just wanted to give the board an update. I know two months ago we passed an ordinance with regards to e-bikes. I appreciate my colleagues supporting me in those endeavors and just wanted to let you know that starting tomorrow we're going to be posting the new signs about the e-bike ordinance in parks and we've already ordered another 150 and so our Parks and Rec and RPM (Real Property Management) teams are going to be working with all of you to make sure that they get out in our parks. We want to make sure

that our parks and trails are safe and that we don't have kids on their e-motorcycles out there terrorizing the families in our parks. So, thank you for your support.

#### TICK SEGERBLOM

Thank you. And just wanted to give a shout-out to Commissioner Jones because this morning they cut the ribbon or kicked off the Red Rock Trail, which is huge. So, thank you so much for all your work on that. It was fantastic. And also, just to remind the booth, we are having some difficulties hearing up here the last couple of meetings. So, whatever's going on, if you can help us old people, I'd appreciate it.

Yeah, I was going to say that. Or we're all just getting old.

I've got one or two. Actually, I guess on that point, Victor is like the best in the business when it comes to this. Other boards that we serve on actually rely on his expertise when they purchase new equipment. So, it probably, I suspect is in the works. But this is probably our fifth board meeting now that we can't really hear very clearly. So, if we could, I don't know, start exploring options for the sound system in this room, which I know is tied to the voting system that we use and understand it's a much more complex purchase than just some new microphones. But I know there are some options out there.

But I guess the other comment I just wanted to make is this Board might remember, we not too long ago had a visit by Mrs. Lucy Jacobs. Lucy Jacobs was a Holocaust survivor who visited this Board actually on a couple occasions. There we are with her. She recently passed away and for those who don't know, Lucy was born in Czechoslovakia in 1928. She spent the Holocaust in multiple camps, including Auschwitz, and then was marched in a death march to Bergen-Belsen. She was liberated by the British in 1945 and moved to the States in 1950. She in the Holocaust lost six siblings and her parents and spent much of her life advocating for Holocaust education, influencing particularly here in this community, a whole lot of people who were able to learn from her wisdom and her experience and just wanted to bring her passing to this board's attention in hopes that her memory be for a blessing. Thank you.

#### MARILYN K. KIRKPATRICK

Mr. Chairman, if I could make one more thing. I'd be remiss if I didn't remind people that safe and sane fireworks are best for all of our firefighters that are out there on Fourth of July. This year is extremely dry. If people are not aware, we have fires all around us, Utah, Arizona, California, even some in our own community. So I just want to remind people that I understand that those fancy fireworks make a lot of sense, but we now have worked with many partners along the strip and many community events to ensure that you can see those same fireworks and not have any injuries to children that the firework might've went the wrong way or a fire in someone's home. Those are things that you can't replace. So, all the pretty fireworks in the world don't help it. So hopefully our call volume is down this year. Cross your fingers.

#### JIM GIBSON

Just wanted to mention that Saturday in Boulder City, a beautiful statue was unveiled commemorating the life of Shane Patton, who was a Navy SEAL (Sea, Air and Land) killed in Afghanistan. He was a part of a

team in a helicopter that was called in to rescue a four-man team that was in distress. 12 people were killed during that incident; he was one of them. A young man, he and his father both had been, he was a Navy SEAL when he died. His father was a Navy SEAL; he was at the ceremony. Both graduated from Boulder City High School, and it was a sobering celebration, but it was exciting to see the outpouring of love that came from the community as they had raised the money to be able to have a world-renowned artist from Poland actually do the design of the statue. And you get a few minutes, it's the Wilbur Park near the City Hall and you get a minute to drive over and see it, you ought to. It's sobering and it reminds us of the sacrifices that so many of these remarkable people have made over the course of time. Thank you.

#### **KEVIN SCHILLER**

Item 44 is to discuss the Interlocal Agreement between the Moapa Valley Fire Protection District and Clark County for the provision of Administrative Services. Commissioner Kirkpatrick.

#### MARILYN K. KIRKPATRICK

Thank you, Mr. Manager. So, I wanted to bring to this Board's attention that it's time to go back out and reevaluate our Interlocal Agreement that we have with the Moapa Valley Fire Board. And for a little bit of history in 2019, it was a volunteer only fire district out there, Chief Castle and I heard concerns from volunteers on how they wanted a stipend to be paid. So, they get like \$20 or \$30 per call out there. And I think honestly they're the only ones that get a little bit of a stipend for showing up. Moapa Valley is unique. There's three actual fire stations that are out there and they service different areas. So often they get caught responding to the tribe. They get caught on I-15 calls. And as you know, those calls we're seeing more and more of I-15 being shut down. So, we always want to be sympathetic to the issues that they have.

And although the call volume hasn't changed, it's been pretty much the same for a very long time, the operations have changed. So, they've since hired an assistant fire chief, which is now no longer living there, but they're no longer part of it. But there's a grant that's based on that. There is a lot of training going on out of state. There's a lot of SOPs (Standard Operating Procedures) that really don't necessarily apply to Moapa, but they're a good cut and paste from what Clark County does. But I didn't take into consideration when I first made this change to what happens with HR (Human Resources) issues, what happens with workman's comp issues, what happens with finance issues, what role does the board play? The advisory board, they're supposed to hear from the community and get back to us. So, what I'd like staff to do is really go back and amend the interlocal agreement as well as any other agreements that they might have.

I want to designate Clark County Fire as the entity responsible for operations and oversight, which is the way that it used to work. But knowing that this is a hybrid model because some people are paid and some people are not. I also want the fire chief to evaluate the district wildfire program, and I want to ensure that we are not employing people out of state as opposed to the residents because that is something that is happening today. So, I want the chief or his designee to really engage. Another situation that happened more than once had a lot of concern about EMTs (Emergency Medical Technicians) out there. We offered, we worked with our partners to see if we couldn't put a bus out there and we were denied twice by the fire chief, and it was never brought to the board. So, all of those issues need to be addressed and we need to help them function as a unique place, but we probably need to go back and kind of tighten up the language so that there's real roles and responsibilities of what people should do.

So, I know that's long-winded, but I want to get the history because I'm sure the history always gets repeated and to make sure that before we go on. And I do think that staff should look at having a full-time administrative person because initially we had asked that that be a part-time position doing just the minutes, that person is now tracking purchasing, tracking grants and it's really not a part-time position.

It's a 40-hour gig. So, I'm not opposed to having that position, but I'd like you to go back and bring it back and I'd like things to stop where they are in time before we start adding new things. So, if you will all support me on that.

#### TICK SEGERBLOM

That doesn't require anything, does it?

#### LISA LOGSDON

I think that's sufficient direction. Unless any other Commissioners have any other input.

#### TICK SEGERBLOM

I see no objection or comments. So, I think you get your way. Thank you.

#### JIM GIBSON

We'll be at recess.

#### **TICK SSEGERBLOM**

Yeah. So, what do we do when we have a hearing at 10 a.m. and we're done at 9:30 a.m.?

#### TICK SEGERBLOM

All right, I think that concludes our agenda. So, time for the second period for public comment. Anyone wishing to speak on any item, please come forward and state your name, spell your last name and you have three minutes.

#### MARGARET ANN COLEMAN

Yes. Good afternoon. My name is Margaret Ann Coleman. C-O-L-E-M-A-N. I'm back to address you. My daughter is in the hospital. I'm needing my money reimbursed. As I told you before, I'm speaking upon [Item] 22 finances and also budget. You granting me the money that was credit and due 2001, that was given to Sisolak as being the Chairman at the time under Rio as Social Security.

Social Services is not complying with my responsibilities and things that's needed for me to move forward here in Las Vegas, Nevada. I had to address you. I can't stay here. You're putting me in Texas. They have put me in California, and I'm not receiving the proper amount. I can't even get an attorney here. You have blocked me totally after helping you with my workman's comp and my pension, 2001 and 2005 all the way up now.

Whereas Abigail has control and putting it in the assistance for homeless people, and they're receiving, and I have not received. This must stop and I must move forward to help my daughter. She's in the hospital. We are needing to go home. 1316 Wizard is my home and Pega has blocked me. And your partnership with Steve Wolfson that was their attorney that was supposed to gave me my workman's compensation under Thomas Hopper.

You guys must speak together and get this straight, let me go, and give me back my money. I opened the door for you. I'm expecting you to let me go if I want to get my reimbursement from you. Thank you. My name is Margaret Coleman. My phone number is \*\*\*-\*\*\*. Call me to pick up the check, please.

#### STEPHANIE PHILLIPS

Morning Commissioners. My name is Stephanie Phillips. P-H-I-L-I-P-S. I have lived in District F for 31 years. I have started two businesses, one being my real estate company, which has been open for 20 years. I also started a non-profit to help hungry and trafficked children in our valley. I'm very involved in community events, politics, and am a co-host on the weekly Veterans in Politics talk show.

District F used to be so clean. We had street cleaners in our neighborhood frequently. I never saw trash build up, overgrown weeds, or homeless people on every street corner. Now as I drive around, not only my neighborhood, but around the district, I see trash on the sides of the street everywhere like it's been there for weeks and even months. The street gutters are full of debris.

My neighborhood rarely sees a street cleaner anymore. There are at least two to three lights out, just in my subdivision, let alone the many others I see driving around District F. The homeless population in this district has grown so much there are tents popping up everywhere. Graffiti is commonplace.

The roads driving up and down Desert Inn, Spring Mountain, and Rainbow, and many others are in awful and terrible condition. They take a toll on our vehicles. The roads look like they haven't been maintained in decades, potholes everywhere. You repave a tiny portion at DI (Desert Inn) and Durango, yet leave the rest of the road in shambles. You scrape the road a couple of hundred feet in the east-west direction on DI at Jones, but again, leave the rest a mess.

When is the Commissioner of District F going to take the initiative to send out cleanup crews, landscape crews, street cleaners, street light workers to replace non-working bulbs, and road pavers so our district doesn't look like a third-world country? We the taxpayers shouldn't have to write in, call in, or come down here to testify. You can clearly see how terrible and dirty the district is. Take the initiative. That's what a leader does. I don't want to hear you don't have the funds to keep up the district. I believe we do. It's about appropriating funds properly.

The District shouldn't have to suffer just because the county had to settle a lawsuit for \$80 million because of the Commission's failures. The candidate who moved into District F for political reasons, just to say she lives here so she can run for County Commission has no idea the issues of District F. She is merely an outsider and those who've been in office but show they don't care about the people will continue to fail the residents of District F.

I just ran for a statewide office in 2024, and if I had the time, I'd run for District F. I know this district inside and out. District F now stands for Failing, Frustrating, and Falling apart. Sorry to say, but you get an F in maintaining District F. You will not be getting my vote in 2026. Thank you.

#### STEVE SANSON

Good morning, Commissioners. Congratulations, April Becker. My name is Steve Sanson, President of Veterans and Politics International, and I appreciate the opportunity to speak for you today.

I'm here to raise serious concerns regarding the conduct and leadership of Clark County Recorder, Debra Conway. As a public official entrusted with overseeing one of the most vital offices in the county, her lack of presence and questionable hiring practices demand accountability.

First, Ms. Conway is frequently absent from the Recorder's office. Multiple reports and firsthand accounts suggest she often doesn't arrive until after most of her staff have gone home. The leadership begins with being present, being available to manage, respond, and support staff and public. Her absenteeism creates a void in supervision, impedes morale, and undermines the efficiency of a crucial county function responsible for maintaining the integrity of property records, marriage license, and other vital documents.

Second, there is a troubling pattern in her hiring practices. A significant number of hirees reportedly come directly from her church, many of whom lack the necessary qualifications or experience. While everyone has a right to fair employment, public service should be based on merit, not personal or religious affiliations. This raises legitimate concerns about favoritism, reverse discrimination, and exclusion of qualified applicants from diverse backgrounds.

Moreover, there are reports of retired staff being rehired as high-paid consultants, creating the appearance of double-dipping at taxpayers' expense.

The public deserves better oversight of how their money is spent and how their offices are run. I urge this Commission to look into these allegations with transparency and seriousness. The Recorder's office belongs to the people of Clark County, not a private circle of friends or church members.

#### AL ROJAS

Okay. I wanted to, my name is Al Rojas, I'm active in the community doing a lot of cleanups on the east side. And I'm going to make a quick report of what's going on and I'm very, very happy to report that Desert Inn between Mayorga and Mountain Vista is cleared up. That area had 10 RVs (Recreational Vehicle), three junked vehicles, four encampments, and the street is all cleaned up.

I want to thank our Commissioners for working with that, listening to our complaints. And I want to thank Metro (Las Vegas Metropolitan Police Department) for now that they are going up there and addressing these people that are living in the RVs and putting stickers on them, so I'm very happy with that.

I want to bring some attention to the Constable's office. We still need help with the Constable's office with some of these abandoned vehicles. And I was going over the ordinance and it says that the Code Enforcement is allowed to put a sticker on there. Now, maybe we have problems with supplies or with funding, but I'm going to be getting on Code Enforcement and maybe they can help the Constable's office. Because every time we call, we never know what's going on with these cars that we're reporting, and they've been there for months. So, the way the ordinance is written, Code Enforcement can help with getting some of these RVs, and putting stickers on them, and getting these cars moving. Once we get these guys moving, maybe they can take care of their cars more, because these things are piling up.

And the only other— I have a minute left. The only other issue that I want them to say is that I'm here, I don't think I'm making a nuisance. There was a comment that— I was thanking the Commissioners and somebody made a comment that we were being a nuisance. I don't think being a nuisance, the community coming up here and addressing these issues is a nuisance because it's going to take the community to help clean this up. We can't expect law enforcement— We can expect to get help from our elected officials, but there's not enough policemen out there without getting the community involved. And I do believe that Neighborhood Watch the program has been very, very effective. Metro's been helping me and I do want to thank the Commissioners. I want to thank the public comment.

But I do believe that we have to get more of the community involved, and get up here, and speak. So that's what I wanted to say and I wanted to thank everybody. Thank you very much.

#### RICHARD MANHATTAN

Good morning, again, Commissioners. Richard Manhattan. I wanted to pick up on a point that Commissioner Kirkpatrick mentioned earlier about fire safety. In our neighborhood at the address, at an apartment or condominium complex, called the Mojave Flats, at 2662 South Decatur. There is what I believe could pose a potential fire hazard.

There is a tree that you can only see from an adjacent property, because it's behind a lot of other trees, that is completely dead and is nestled within a bundle of other living trees that, if in the right conditions, this dead tree might catch fire and ignite the adjacent trees and maybe even some property.

I've spoken with someone in Code Enforcement to request that someone address the tree or that they bring the dead tree to the attention of the condominium HOA (Homeowners Association). And it was perplexing for the person in Code Enforcement because apparently there is a jurisdictional boundary line between this community and the apartment community immediately adjacent to it.

And I'm not sure if anyone has dealt with it, because the tree's still there, it's still dead, and it hasn't been removed. And I imagine that because of this jurisdictional boundary issue that it hasn't been addressed. And so, I wanted to come today to bring it to your attention. I'm not exactly sure whose district it's in, unfortunately, and I apologize for not checking that beforehand.

And separately, I wanted to clarify my statement earlier. I realized I spoke very quickly. I wanted to clarify by restating that my request is that this Board ask its staff, and also the County Manager, to look into non-employee whistleblower protections.

I would also ask that a copy of the county's existing whistleblower protection for staff be provided to me by the City Manager or by anyone. I think that there may be some protections already for individuals who are in the procurement process, or who are bidding on contracts, and who may not be necessarily successful, but because they're a part of the process, those protections may already exist, and it would be useful to know what that policy is.
