

**AMENDMENT NO. 5  
CBE NO. 604130-16  
ORACLE MASTER AGREEMENT**

**THIS AMENDMENT** is made and entered into effective as of the 1st day of April 2022, by and between CLARK COUNTY, NEVADA (hereinafter referred to as “COUNTY”), and ORACLE AMERICA, INC. (hereinafter referred to as “PROVIDER”).

**WITNESSETH:**

**WHEREAS**, the parties entered into the Oracle Master Agreement dated July 1, 2016 (Clark County reference number CBE 604130-16, Oracle reference number US-GMA-789270) (together with all prior amendments and addenda thereto, the CONTRACT); and

**WHEREAS**, the parties desire to amend the CONTRACT.

**NOW, THEREFORE**, the parties agree to amend the CONTRACT as follows:

1. The text of General Terms Section 2, Master Agreement Term and Applicable Schedules (as previously revised per Amendment No. 4 to the CONTRACT), which is set forth under the heading “WRITTEN FROM AMENDMENT 4” below, is deleted in its entirety and replaced with the text under the heading “REVISED TO READ” below.

**WRITTEN FROM AMENDMENT 4:**

Orders may be placed under the Master Agreement from the Effective Date (indicated below in Section 17) until March 31, 2022. As of the Effective Date, the following Schedules are incorporated into the Master Agreement: **Schedule C - Cloud Services-Public Sector; Schedule H - Hardware-Public Sector, Schedule P - Programs-Public Sector.**

The Schedules set forth terms and conditions that apply specifically to certain types of Oracle offerings which may be different than, or in addition to, these General Terms.

**REVISED TO READ:**

Orders may be placed under the Master Agreement from the Effective Date (indicated below in Section 17) until May 31, 2022. As of the Effective Date, the following Schedules are incorporated into the Master Agreement: **Schedule C - Cloud Services-Public Sector; Schedule H - Hardware-Public Sector, Schedule P - Programs-Public Sector.**

The Schedules set forth terms and conditions that apply specifically to certain types of Oracle offerings which may be different than, or in addition to, these General Terms.

2. The revisions contained herein are effective as of April 1, 2022.
