PROFESSIONAL SERVICES CONTRACT FOR STAFF AUGMENTATION FOR QUALITY ASSURANCE OR INDEPENDENT ASSURANCE TESTING AND INSPECTION ON VARIOUS PUBLIC WORKS PROJECTS

SUPPLEMENTAL NO. 4

THIS SUPPLEMENTAL NO. 4, made and entered into this 16th day of April, 2024, between CLARK COUNTY, NEVADA, a political subdivision of the State of Nevada, hereinafter referred to as "COUNTY" and Ninyo & Moore Geotechnical and Environmental Sciences Consultants, a corporation duly authorized to do business under the laws of the State of Nevada, hereinafter referred to as "ENGINEER."

WITNESSETH

WHEREAS, on 21st day of May, 2019, the COUNTY and the ENGINEER entered into a contract for professional services for Staff Augmentation for Quality Assurance Testing for various Public Works Projects ("Contract"); and,

WHEREAS, on the 21st day of July, 2020, the COUNTY and the ENGINEER entered into Supplemental No. 1 to the Contract to provide continued professional services and additional funding; and,

WHEREAS, on the 2nd day of February, 2021, the COUNTY and the ENGINEER entered into Supplemental No. 2 to the Contract to provide continued professional services and additional funding; and,

WHEREAS, on the 7th day of March, 2023, the COUNTY and the ENGINEER entered into Supplemental No. 3 to the Contract to extend the term; and,

WHEREAS, the Projects (as defined in the Contract) for which Work Orders have been assigned to the Engineer are under construction and a Contract extension is needed for the ENGINEER to continue providing Quality Assurance testing and inspection, including review of final QC documents and support for the remainder of the durations of the Projects.

NOW, THEREFORE, for and in consideration of the premises and mutual covenants herein contained, the parties mutually agree to supplement the Contract dated the 21st day of May, 2019, as follows:

ARTICLE V TERM AND TERMINATION

5.01 – GENERAL shall be changed to read as follows:

Subject to the provisions set forth in Sections 5.02 and 5.03, hereof, the ENGINEER shall perform the Services requested by the COUNTY as set forth in this Contract during the time period beginning May 21, 2019, and ending after acceptance of all Projects(s) assigned to the ENGINEER by Work Orders provided to the ENGINEER but no later than December 31, 2024.

Except as provided herein, this Contract shall remain in effect until December 31, 2024.

The remainder of the Contract dated May 21, 2019, shall remain unchanged.
