# ASSIGNMENT AGREEMENT FOR PROFESSIONAL SURVEYING SERVICES

THIS ASSIGNMENT AGREEMENT ("Assignment") is made and entered into as of this 19<sup>th</sup> day of August 2025, by and among the County of Clark, Nevada, a political subdivision of the State of Nevada, hereinafter referred to as "County", Kleinfelder, Inc., and MHP Limited LLC. Each of the above is a "Party" and collectively are "Parties".

#### **WITNESSETH**

**WHEREAS**, the County and Kleinfelder, Inc. have previously entered into an agreement for professional surveying services, hereinafter referred to as "Contract", as set forth below; and

WHEREAS, the survey department of Kleinfelder, Inc. has been acquired by MHP Limited LLC; therefore, requiring an assignment of the County's existing Contract with Kleinfelder, Inc. to MHP Limited LLC; and

WHEREAS, the County is willing to consent to the assignment of the aforementioned Contract from Kleinfelder, Inc. to MHP Limited LLC so long as MHP Limited LLC commits to being bound by this Assignment and the Contract and accepts and complies with all of the terms, conditions, rights, interests, restrictions, duties, liabilities, and obligations of Kleinfelder, Inc. under the Contract.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants herein contained, it is mutually agreed by and between the Parties as follows:

#### **PARTIES AGREE**

- Kleinfelder, Inc. hereby assigns and transfers to MHP Limited LLC all the rights, obligations, terms, conditions, restrictions, interests, duties, and liabilities it has in the following Contract between Kleinfelder, Inc. and the County:
  - Badura Avenue, Durango Drive to Tenaya Way (Project No. R242BFT) entered into on May 8, 2024.

- 2. MHP Limited LLC hereby accepts the assignment and transfer of all rights, obligations, terms, conditions, restrictions, interests, duties, and liabilities under the Contract and agrees to be fully bound under the Contract and this Assignment.
- 3. Upon execution of this Assignment, MHP Limited LLC will be responsible for all liabilities, terms, conditions, obligations, commitments, and duties under the Contract and those arising from or connected to the Contract, including, but not limited to, those that pre-date this Assignment and those relating to the insurance and indemnity requirements.
- 4. MHP Limited LLC agrees that there will be no changes in the staff, employees or personnel assigned to perform the services of the Contract, except with written permission of the County.
- 5. The County consents to the assignment of the Contract to MHP Limited LLC subject to the terms and conditions of this Assignment.
- 5. Except as set forth in this Assignment, all terms, conditions, and provisions of the Contract are unchanged and remain in full force and effect, and shall be binding on MHP Limited LLC.
