

**RESOLUTION TO LEVY  
FY 2025 AD VALOREM TAX RATES**

WHEREAS, NRS 361.460 requires that immediately after the Nevada Tax Commission certifies the combined tax rates, the Board of County Commissioners shall, by Resolution, levy the tax rates; and,

WHEREAS, on June 25, 2024, it is anticipated that the Nevada Tax Commission shall certify the combined tax rates to the boards of county commissioners; and,

WHEREAS, each local government entity may levy a tax rate equal to, or less than, the maximum allowed.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Clark County, Nevada, does hereby levy, effective immediately after certification of the combined tax rate by the Nevada Tax Commission, the following ad valorem tax rates required for the fiscal year beginning July 1, 2024, designating the number of cents per \$100 of assessed valuation:
