RESULTS OF CANVASS
2024 GENERAL ELECTION
NOVEMBER 5, 2024

The results of the November 5, 2024, General Election were canvassed comparing the computer printout of ballots counted and the results thereof, with the official ballot statement for each of the 917 precincts utilized in this election.

There were 195 discrepancies in the 1,033,285 ballots cast in the 917 precincts. One hundred nine (109) voters fled the voting machine prior to casting their vote, forty-three (43) reactivation errors; forty-three (43) voted in the wrong precinct. However, there were no tabulation errors in the 917 precincts, and the foregoing irreconcilable discrepancies would not alter the outcome of any contests in the General Election.

Nineteen thousand seven hundred twenty-four (19,724) provisional ballots were cast during the election, eighteen thousand five hundred sixty-five (18,565) were verified and counted. One thousand one hundred fifty-nine (1,159) were not eligible to vote.

Audits were performed according to NRS 293B on the hash code of our ICX voting machines and the VVPAT rolls for 2% of all machines used in the election. No discrepancies were identified. The accuracy certification board also certified the functionality of our tabulation system, to include our mail ballot readers, ICX voting machines, and Agilis mail ballot processing machine. All systems were found to be 100% accurate in the tabulation of votes and processing of mail ballots. The tests were performed before the start of early voting, the day before Election Day, and a post-election test the day after the election.

There were no tabulation errors in the 917 precincts. Therefore, as the duly appointed Registrar of Voters of Clark County, Nevada, I do hereby certify to the Clark County Board of Commissioners that the results of the canvass of this election are deemed certifiable.

Audit of Voter Verifiable Paper Trail Printers

In accordance with Chapter 293B of the Nevada Administrative Code, an audit was conducted of 87 (2% of 4,350) machines used in the election. The randomly selected ICX touchscreen voting machines, and the voter verifiable paper trail printer that was used with each machine, were used in this audit. The audit was conducted as follows:

- a. For each machine selected, the printed record produced by the machine during voting was manually tabulated by a panel of Clark County Election Department staff members.
- b. The electronically recorded results for each machine were independently tabulated using the election tabulation software.
- c. The results were compared.

The results of the audit showed that 100% of the time, the electronically recorded results exactly matched the selections printed on the paper tape.
