FIRST AMENDMENT TO INTERLOCAL AGREEMENT

THIS FIRST AMENDMENT TO INTERLOCAL AGREEMENT ("*Amendment*"), by and between THE BOARD OF REGENTS OF THE NEVADA SYSTEM OF HIGHER EDUCATION, ON BEHALF OF THE UNIVERSITY OF NEVADA, LAS VEGAS, a constitutionally created entity of the State of Nevada ("*UNLV*") and CLARK COUNTY, NEVADA, a political subdivision of the State of Nevada ("*County*"), and individually and collectively referred herein as the "*Party*" and "*Parties*", respectively, is effective on the later of the date ("*Effective Date*") approved by the Board of County Commissioners ("*BCC*") or the Board of Regents ("*Board of Regents*" or "*Designee*").

RECITALS

WHEREAS, on April 5, 2021, the Parties entered into an Interlocal Agreement ("*Agreement*") for UNLV to install spectator bleachers at the Myron Partridge Stadium and the County agreed to provide funding for a portion of the construction cost for the Project (as defined in the Agreement); and

WHEREAS, Nevada Revised Statute ("*NRS*") 277.180 provides that one or more public agencies may enter into contracts for the performance of desired services; and

WHEREAS, due to issues encountered during construction, UNLV cannot complete the Project by September 30, 2022 and is requesting an extension of time to complete the Project.

NOW, THEREFORE, in consideration of the promises and mutual covenants and agreements herein contained, the Parties agree to the following:

The Parties agree to amend the following provisions of the Agreement:

- A. Article III Section 1. Delete September 30, 2022 and replace with March 31, 2023
- B. The Parties may execute this Amendment in counterparts. Each of these counterparts, when signed and delivered, is deemed an original and, taken together, constitutes one and the same instrument.
- C. Except as expressly amended herein, all other provisions of the Agreement shall remain in full force and effect.
