**AMENDMENT NO. 1
CBE NO. 606461-22
RARE PLANT PROPAGATION RESEARCH PHASE 2**

THIS AMENDMENT is made and entered into this ____ day of _____ 20__ , by and between CLARK COUNTY, NEVADA (hereinafter referred to as “COUNTY”), and U.S. GEOLOGICAL SURVEY (hereinafter referred to as “AGENCY”).

WITNESSETH:

WHEREAS the parties entered into an agreement under CBE Number 606461-22, entitled “Rare Plant Propagation Research” dated January 17, 2023 (hereinafter referred to as AGREEMENT); and

WHEREAS the parties desire to amend the AGREEMENT.

NOW, THEREFORE, the parties agree to amend the AGREEMENT as follows:

1. Exhibit A, Scope of Work, Page 9, Project Schedule, Milestones and Deliverables, Description of Deliverables and Milestones No.20 has been revised as follows.

“ORIGINALLY WRITTEN”

20. Seed available for ERVI propagated from soil seed bank (ERVI**s**b1). Viable ERVI plant materials developed through seed bank emergence method during this project will be made available for future research or out planting. AGENCY’s availability of nursery stock will be confirmed by COUNTY site visit unless otherwise approved by COUNTY.

“REVISED TO READ”

20. Middle Muddy River Seed Bank Emergence Data. AGENCY shall deliver an Excel workbook documenting all species that emerged from ERVI soil seed bank samples collected from the Middle Muddy River site in fall 2023. The workbook data shall document all species that emerged and their counts from the seed bank collection. The data shall include details of the greenhouse emergence trial and the composition of the seed bank at the Middle Muddy River site (*i.e.*, native, nonnative, and ERVI species; seedling counts; timing of emergence associated with watering and chemical treatments).

2. Appendix 1, Milestone/Deliverable/Invoicing Schedule Table, Page 15, Deliverable No. 14 has been revised as follows:
