This is a request for PF zoning for approximately the northern 120 feet of both parcels for an access road and approximately the southern 390 feet of APN 191-30-501-004. The zone change is necessary for a proposed zone reservoir facility for the Las Vegas Valley Water District that straddles the City of Henderson and unincorporated Clark County jurisdictional boundary line. The applicant states that PF zoning is appropriate since the zone change will support the installation of critical public water infrastructure.

The applicant shall demonstrate the proposed request is consistent with the Master Plan and is in compliance with Title 30.

Analysis

Comprehensive Planning

In addition to the standards for approval, the applicant must demonstrate the zoning district is compatible with the surrounding area. The request for PF zoning is compatible with the surrounding area. The adjacent parcel to the east is zoned PS (Public and Semipublic) within the City of Henderson, which is the zoning equivalent of PF zoning for unincorporated Clark County. With the proposed facility being a public facility operated by the Las Vegas Valley Water District, the request meets the purpose of PF zoning as stated in Title 30, which states "The PF district is established to accommodate government facilities, structures, and uses, and related buildings, structures, and accessory uses". The request complies with Goal 3.3 of the Master Plan which promotes maintaining and protecting the quality, supply, and reliability of Clark County's water resources for current and future residents. For these reasons, staff finds the request for PF zoning is appropriate for this location.
