Redevelopment Agency of Clark County, a public body ("RDA") submitted to you a Conditional Offer to Purchase dated August 21, 2025, which was accepted on August 25, 2025. Please consider this RDA's Amendment I to Conditional Offer to Purchase Real Property (the "Amendment I") with respect to the above referenced property, subject to the following terms and conditions.

AMOUNT OF OFFER:

On behalf of the RDA, the sale and purchase price for the Property shall be a cash offer of Two Million Four Hundred and Five Thousand Dollars (\$2,405,000) ("Purchase Price").


