

**CLARK COUNTY RECOVERY GRANT
FIRST AMENDMENT TO INTERLOCAL AGREEMENT**

This First Amendment to the Clark County Recovery Grant interlocal Agreement ("AMENDMENT") is by and between CLARK COUNTY, NEVADA (the "County") and WORKFORCE CONNECTIONS (the "Subrecipient") for the WORKFORCE DEVELOPMENT PROGRAM (the "Program").

WHEREAS, the County and Subrecipient entered into that certain Clark County Recovery Grant Interlocal Agreement ("Original Agreement") approved and executed on March 19, 2024 in support of the "Program"; and

WHEREAS, the Subrecipient has identified areas that require an amendment to the Original Agreement; and

NOW, THEREFORE, BE IT RESOLVED that the conditions and limitations of the Original Agreement be modified as follows:

1. The County agrees that Subrecipient may seek reimbursement of sales tax paid (as required) for the Program.

2. Section C subsection 7 shall be deleted and replaced in its entirety as follows:

To obtain reimbursement, Subrecipient must submit the request utilizing the County provided Request for Reimbursement and Financial Report (Exhibit C) form within 90 days after month end. Exhibit C must be supported by accounting documentation, including but not limited to detail general ledgers, payroll registers, time records, invoices, and contracts. Expenditures will be reviewed for consistency with the approved County Recovery Funds budget and budget justification as outlined in Exhibit A and the Scope of Services outlined in Exhibit B. Any expenditures incurred outside the approved County Recovery Funds budget and budget justification and/or Scope of Services or that are not supported by appropriate documentation will be denied.

Prior to the commencement of the Program, the County shall provide to Subrecipient an advance payment of the costs Subrecipient anticipates expending during the first three (3) months of the Program. The County will continue to provide 90 days of advance funding through the life of the award. Each month following the initial advance the County will provide the subrecipient with one month of advance funding. The subrecipient will be allotted 90 days from the end of the month that the advance was received for to reconcile funds. To obtain the initial advance payment, Subrecipient must provide the County with the estimated amount of the anticipated costs of the Program by budget line items. For the next twelve (12) advances the County

will advance one third of the amount of the initial advance. Subsequent advances will be adjusted to take into account the average of all previous reconciliation amounts. Only anticipated costs which would be eligible for reimbursement from County Recovery Funds under this Agreement shall be included in the advanced payment. Any reimbursements otherwise payable to Subrecipient for eligible costs expended during the final three (3) months of the Program will be offset by the advance payment.
