The immediate response area encompasses long stretches of Interstate 15, a transcontinental shipping route that is one of Union Pacific Railroad's main lines, and 45 miles of natural-gas-supply pipeline. Critical infrastructure also includes power-generating

stations, Nellis Air Force Base (which is slated to be the primary training ground for the F-35 that will maintain the superiority of our air power through the technology of this weapon system), Hoover Dam, Davis Dam, large complexes of liquid petroleum tanks, BMI Complex (production site of chlorine gas, chlorine liquid and titanium), and Switch Communications. Numerous festivals and recreational sites, including Lake Mead, attract visitors from around the globe. Regional firefighters provide structure and wildland fire protection, emergency medical services, backcountry/technical rescue, and hazardous materials mitigation. The rural, primarily volunteer personnel are frequently first-on-scene for traumatic incidents involving all area roadways, interstates, and railyards. Crucial to interstate commerce, hazardous materials and large numbers of people traverse the area. Interstate 15 (I-15), is one example. It is a major Interstate Highway in the western United States, running through Southern California and the Intermountain West. I-15 begins near the Mexican border in San Diego County and stretches north to Alberta, Canada, passing through the states of California, Nevada, Arizona, Utah, Idaho, and Montana.

Multiple communities within this region's immediate response area, including all of Moapa Valley, are federally recognized as disadvantaged communities highly subject to economic and climate hardships. More than one in twelve people live in poverty, and more than one in ten people [under the age of 65] live with disabilities (census.gov). Because it is a special district, Moapa Valley Fire Protection District is exclusively responsible for all expenses related to personnel, apparatus, facilities, equipment, capital purchases, and administrative overhead. The vast majority of the operating budget is allocated toward fixed-cost items needed to operate three fire stations and support sixty uniformed personnel and other expenses such as utilities, fuel, uniforms and training. In

2022, little more than five-thousand dollars remained of \$953,389 revenue dollars once expenses of \$948,268 were paid. Revenue was

professional services, repairs and maintenance, insurance, medical, supplies and equipment. Moapa Valley receives no funding from city or county general funds. Despite a 30% increase in call volume

from consolidated tax, transport fees, wildland revenue, and interest income. Expenses consisted of salaries/benefits,

over the last five years, the revenue level—which comes from consolidated sales tax—declined due to COVID and remained stagnant. Alternate, unsuccessful attempts to secure funding include requests to HSGP, AFG, and American Rescue. Ongoing increases in hazardous materials transportation and of solar arrays with lithium ion storage add risk. Call volume has increased 30% in the last 5 years, yet maintaining and training the volunteer firefighting force is progressively more difficult. Climate change, the challenges of and lessons learned from the pandemic,

and corresponding regulatory agency requirements have forced substantial operational changes to regional emergency-response procedures. Additionally, Nevada's largest solar plant opens this year. The 18-square mile plant is within the Districts' first-in area providing mutual aid response to Clark County. Emerging industries in the valley are shipping more ammonia than ever before. At least 15 tier 2 hazmat facilities may necessitate CCFD-rural and MVFPD response.

Moapa Valley Fire District (MVFD) is a combination, all-hazard fire department supported by 60 volunteers and just 1 paid firefighter operating out of 3 stations to protect roughly 267 square miles in rural Clark County in Southern Nevada. The response area of MVFD includes the communities of Moapa, Logandale and Overton, as well as Federal, State, and local recreation areas such as the Lake Mead National Recreational Area, Logandale Trails System, Valley of Fire, Lost City Museum, and Overton Wildlife Management Area. The rural nature of the area, the critical infrastructure within it (detailed above in this application), and the continuous need for interagency operability all demand that reliable communication equipment be made available to firefighters. Regional firefighters provide structure and wildland fire protection, emergency medical services, backcountry/technical rescue, and hazardous materials mitigation. Inter-agency cooperation is essential. Contributing factors include increasing call volume, intensifying natural disasters, an abundance of critical infrastructure, a population base that is predominantly low-income and vulnerable to hazards, and the rural nature of the response area. Moapa Valley's volunteer personnel are frequently first-on-scene for traumatic incidents involving all area roadways, interstates, and railyards. Public lands adjoin and surround the district. Response depends largely on the volunteer departments because most Federal firefighting resources are only deployed seasonally. The majority of the open space is managed by the Bureau of Land Management, National Park Service, Fish and Wildlife Service, or US Forest Service. In line with the Southern Nevada Operating Plan, all jurisdictions provide mutual aid during the initial attack period (24 hours). The permanent resident population is just over 13,000. Seasonally, the population

swells with the arrival of special events and temporary residents. Snowbirds increase the population by as much as 1,100 people. Easily accessible from Las Vegas, numerous festivals and recreational sites attract visitors from around the globe. In addition to Lake Mead tourism, the Clark County Fair & Rodeo has the largest draw, bringing 120,000 participants annually. Placing extreme demand on the firefighters, other events that attract thousands of people each year include the Bluegrass Festival, the Fall Festival Car & Motorcycle Show, the Pomegranate Arts & Crafts Festival, the Hump N Pump 4-Wheeler Fair, and multiple marathons.
