REVOCABLE LICENSE AGREEMENT

COUNTY OF CLARK, a political subdivision of the State of Nevada, Grantor, for and in consideration of One Dollar (\$1.00) and other valuable consideration, receipt of which is hereby acknowledged, does hereby grant to CITY OF NORTH LAS VEGAS, a political subdivision of the State of Nevada, Grantee, its agents and assigns, a revocable license for the right of ingress and egress upon, over, under, and across the hereinafter described area in Exhibit "A" and "A-1" and Exhibit "B" and "B-1" and located within 215 Beltway Right-of-Way for the purpose of constructing, operating, maintaining, repairing, reconstructing and removing sewer line (herein the "improvements") depicted in Exhibit "C" attached hereto and made a part hereof by this reference. Grantee agrees that it may only utilize the area depicted in Exhibit "A" and "A-1" and Exhibit "B" and "B-1" and only for the purposes set forth herein.

Prior to any construction, maintenance, repair reconstruction and/or removal of the improvements or other related activities on the Grantor's property, Grantee, at its sole cost and expense, shall submit plans acceptable to the Grantor, prepared in compliance with the Nevada Revised Statutes (NRS), and shall secure any and all permits required by the Grantor. The plans shall also include detailed plans for the protection of traffic in accordance with applicable standards including but not limited to the Roadside Design Guide, Edition 3rd by the American Association of State and Highway Transportation Officials (AASHTO).

Grantee shall not acquire or assert any vested right or interest in any of the Grantor's property. Within One hundred and eighty (180) calendar days after receiving written notice from the Grantor to reconstruct, modify, remove or relocate all, or a portion of said improvements, the Grantee shall commence activities necessary for such reconstruction, modification, removal or relocation and shall, after obtaining the necessary permit(s) to do so, complete the required action at Grantee's sole cost and expense, within a reasonable time thereafter, not to exceed one hundred and eighty (180) calendar days unless such time is extended in writing by the Grantor at the Grantor's sole discretion. Grantee shall be responsible for all damages, to whomever, caused by Grantee's actions and or failure to reconstruct, remove, modify or relocate any improvements within the aforesaid time, provided, however, Grantee's failure is not caused by Grantor's failure to issue any necessarypermits, so long as Grantee has complied with the permit conditions. Additionally, a Clark County Encroachment Permit must be obtained through Clark County Public Works in order to perform this work.

Notwithstanding any other provision of this Agreement, in the case of any requirement of the law or an emergency or threat to the public's health, safety or welfare (an "Emergency Event") caused by or an emergency or attributed to the improvements, or by Grantee's installation, construction, reconstruction, maintenance, and repair of the improvements, or if Grantee fails to maintain the improvements, Grantee hereby agrees to immediately adjust, modify, remove, replace, reinstall, repair, or reconstruct said improvements.

The Grantor and its successors and assigns may revoke the license with or without cause upon the giving of one hundred and eighty (180) calendar day written notice to Grantee. Upon revocation of this license, the Grantee shall, at its sole expense, if requested by the Grantor or its successors and assigns, remove conflicting improvements placed by the Grantee from the Grantor and its successors and assigns' property. Prior to removal and replacement of

improvements, Grantee shall secure, at its sole expense, all permits and approvals required by the Grantor and its successors and assigns for removal and relocation.

This license is conditioned upon the Grantee indemnifying, defending and holding harmless the Grantor, its officers and employees, and its successors and assigns from all losses, damages, fines, liability, claims, demands, causes of action, costs, expenses, judgments, including reasonable costs of investigation, reasonable attorneys fees and expenses, reasonable consultants' fees and expenses, reasonable expert witnesses' fees and expenses and all court or arbitration or other alternative dispute resolution costs allegedly caused or caused by, arising out of or resulting from the Grantee, its employees, agents, consultants and/or contractors' use of the area described herein, arising out of or in connection with the rights and obligations set forth herein, or relating to any act, omission or conduct of Grantee, its employees, agents, consultants and/or contractors related to the use of the area set forth herein. The Grantee shall indemnify, defend and hold harmless the Grantor and its successors and assigns as set forth in this paragraph, even if the allegations of the claims or causes of action are groundless, false or fraudulent. This license is further conditioned upon the understanding that the rights herein are revocable.
