Thank you, Mr. Chairman, we were asked by the legislature to show our support for the bill that we have before them this is actually a bill that is being carried by the Majority Leader of the Senate, and what this bill does is actually rolls over the current property tax for the officers. It's been in place for 30 years. Statute requires that you come back and revisit it. If we don't pass this there's- if this bill does not pass it's a matter of 825 officers or about \$160 million dollars lost to the Metro agency. So, for myself, I think this is important enough that we come and we vote to ensure that those officers stay on our streets.
