### SUPPLEMENTAL NO. 4 TO THE PROFESSIONAL ENGINEERING SERVICES CONTRACT FOR TRAFFIC MANAGEMENT AUGMENTATION SERVICES

#### WITNESSETH

WHEREAS, on December 4, 2018, the COUNTY and the ENGINEER entered into the Professional Engineering Services Contract for Traffic Management Staff Augmentation ("Contract");

WHEREAS, on August 17, 2021, the COUNTY and the ENGINEER entered into Supplemental No. 1 ("Supplemental No. 1") acknowledging the ENGINEER name change, updating the Direct Salary, increasing the amount payable due to additional traffic improvements and amending the time for performance;

WHEREAS, on June 7, 2022, the COUNTY and the ENGINEER entered into Supplemental No. 2 ("Supplemental No. 2") for other traffic improvements that were anticipated, and an increase in the amount payable along with a time extension needed for the additional work:

WHEREAS, on March 5, 2024, the COUNTY and the ENGINEER entered into Supplemental No. 3 ("Supplemental No. 3") for additional traffic and pavement improvements that were anticipated, and an increase in the amount payable along with a time extension needed for the additional work; and

**WHEREAS**, the COUNTY desires to extend the time of performance to allow for completion of work orders.

**NOW THEREFORE,** for and in consideration of the premises and mutual covenants herein contained, it is agreed as follows:

#### ARTICLE IV: TIME OF PERFORMANCE

### 4.01 Time of Performance, the last paragraph shall be revised as follows:

Except as otherwise provided in each Work Order, the ENGINEER shall complete all Basic Services and authorized Special Services prior to December 31, 2026, unless the COUNTY amends such date.

The remainder of the Contract, Supplemental No. 1, Supplemental No. 2, and Supplemental No. 3 remains unchanged.
