

My name is Denise Bolaños and I'm writing to you on behalf of Make the Road Nevada and more importantly, on behalf of the hardworking street vendors of the community.

The proposed regulations pose a real threat to the livelihoods of the people who rely on street vending to survive and by extension, the community's economic stability. It's crucial to highlight that these vendors aren't just **individuals** trying to make ends meet; this isn't just a side hustle for extra income, these people are often the sole breadwinners for entire families.

The ripple effect if these regulations were to be enacted cannot be emphasized enough, but I'll try. These arbitrary distance requirements would force vendors to relocate, distancing them from their established customer base and severely disrupting their income streams. A ban on door-to-door sales would further limit their ability to reach customers directly which limits their sales opportunities and earnings. With these restrictive measures, the Board is not only undermining the economic well-being of these families but also fracturing the social fabric of our community.


