Summary:

On January 3, 2024, Request for Qualification (RFQ) No. 606830-23 was advertised on the Clark County Purchasing website and in the Las Vegas Review Journal. Submittals were requested for Sex Offense Assessment and Counseling.

(NBE), Family and Child Treatment dba FACT (NBE), Healing Hooves LLC (NBE), Integrated Psychological Solutions, LLC (NBE), John S. Pacult LCSW Inc. (NBE), LBR Mental Health PLLC (NBE), Nevada Mental Health Associates, LLC (NBE), Red Rock Psychological Health (NBE), Shining Star Community Services, LLC dba Shining Star (NBE), Specialized Alternatives for Families and Youth of Nevada, Inc. (NBE).

An Ad-Hoc Committee comprised of 4 individuals from Family Services and Department of Juvenile Justice Services reviewed and evaluated the submittals. Description of Ad Hoc Committee

Evaluator A:

JPO Supervisor since 2015. Current Supervisor for the past 5 years of the Sex Offense Unit. Direct communication and professional relationships with all of the current vetted providers on the current contract. Member of ATSA, organization for best practice standards for youth/adults to sexually offend. Well aware of current therapy practices for youth who sexually offend. Conduct quarterly JSO Coalition Meetings with all current vetted providers.

Evaluator B:

Been employed with DJJS for over 22 years, have been in management for the past 5+ years. Experience in begin part of an evaluation committee within the department as well.

Evaluator C:

Clark County Family Service Manager who oversees Mental Health and Placement Services at the Department of Family Services. Is a Licensed Clinical Social Worker with over 20 years' experience working with populations in need of treatment related to concerns with mental health, trauma and substance misuse. Educational background includes a Master Degree of Social Work (MSW) and Master of Health Science (MHS) in Addiction Studies. Is a Certified Clinical Trauma Professional (CCTP), 16 years working with Clark County child welfare establishes relevant background, comprehensive knowledge, understanding of best clinical practice standards and the overall importance of best practice service delivery to family systems experiencing complex trauma. Within the 16 years of service, many of those years involved clinical practice at the Southern Nevada Children's Assessment Center (SNCAC) as a provider of therapeutic support services and mental health consultation to the SNCAC Child Sexual Abuse Review Team (CSART).

Evaluator D:

A Licensed Clinical Social Worker who has been overseeing mental health programs and services since 2014.
