

**AMENDMENT NO. 1
CBE NO. 606189-22
MAIL BALLOTS 2022 ELECTION**

THIS AMENDMENT is made and entered into this day of _____ 2022, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and RUNBECK ELECTION SERVICES, INC., (hereinafter referred to as "PROVIDER").

WITNESSETH:

WHEREAS, the parties entered into an agreement under CBE Number 606189-22, entitled "Mail Ballots 2022 Election" dated May 17, 2022 (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. First Whereas, Page 1, Second Paragraph:

ORIGINALLY WRITTEN:

WHEREAS, PROVIDER has the personnel and resources necessary to accomplish the PROJECT within the required schedule and with a budget allowance not to exceed

\$4,200,000, including all travel, lodging, meals and miscellaneous expenses; and

REVISED TO READ:

WHEREAS, PROVIDER has the personnel and resources necessary to accomplish the PROJECT within the required schedule and with a budget allowance not to exceed

\$8,400,000, including all travel, lodging, meals and miscellaneous expenses; and

2. Section : Term of Contract, Page 1:

ORIGINALLY WRITTEN:

COUNTY agrees to retain PROVIDER for the period from March 31, 2022 through December 31, 2022. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of this Contract.

REVISED TO READ:

COUNTY agrees to retain PROVIDER for the period from March 31, 2022 through December 31, 2022, with the option to renew for 2, one-year periods subject to the provisions of Section II and VIII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of this Contract.

3. Section II: Compensation and Terms of Payment, Page, Section A:

ORIGINALLY WRITTEN:

Compensation:

COUNTY agrees to pay PROVIDER for the performance of services described in the Scope of Work (Exhibit A) and in accordance with the fees therein for the not-to- exceed amount of \$4,200,000. COUNTY'S obligation to pay PROVIDER cannot exceed the not-to-exceed amount. It is expressly understood that the entire work defined in Exhibit A must be completed by PROVIDER and it shall be PROVIDER'S responsibility to ensure that hours and tasks are properly budgeted, so the entire PROJECT is completed for the said fee.

REVISED TO READ:

Compensation:

COUNTY agrees to pay PROVIDER for the performance of services described in the Scope of Work (Exhibit A) and in accordance with the fees therein for the not-to- exceed amount of \$8,400,000. COUNTY'S obligation to pay PROVIDER cannot exceed the not-to-exceed amount. It is expressly understood that the entire work defined in Exhibit A must be completed by PROVIDER and it shall be PROVIDER'S responsibility to ensure that hours and tasks are properly budgeted, so the entire PROJECT is completed for the said fee.

This Amendment No. 1 represents an increase not to exceed \$4,200,000.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
