**AMENDMENT NO. 1
CBE NO. 605646-20
ADJUSTING SERVICES FOR GENERAL LIABILITY CLAIMS**

THIS AMENDMENT is made and entered into this _____ day of _____, 20 25, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and CARL WARREN & COMPANY OF NEVADA (hereinafter referred to as "PROVIDER").

WITNESSETH:

WHEREAS the parties entered into an agreement under CBE Number 605646-20, entitled "Adjusting Services for General Liability Claims" dated July 27, 2020 (hereinafter referred to as CONTRACT); and

WHEREAS the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. Page 1, Section 1: Term of Contract, 1st sentence,

"COUNTY agrees to retain PROVIDER for the period from date of award through June 30, 2021, with the option to renew for four (4), one-year periods subject to the provisions of Sections II and VIII herein."

REVISED TO READ:

"COUNTY agrees to retain PROVIDER for the period from date of award through June 30, 2021, with the option to renew for six (6), one-year periods subject to the provisions of Sections II and VIII herein."
