The board may authorize such additional compensation at the rate of seventy dollars per hour if it is satisfied that the additional hours of service were justified and necessary." The Hearing lasted approximately 5 hours and the Decision was 7 pages long due to multiple witness statements / testimony regarding the abuse allegations."
