2. Describe your interest in serving as a Hearing Officer. Include information not already mentioned about yourself, your experience, and background that supports your interest.

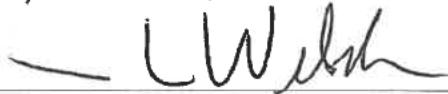

Time constraints are balanced with the pertinence of the evidence and testimony presented. I enjoy balancing being amiable, efficient and making timely decisions.

Since becoming a hearing officer in 2016, I have learned a great deal from the County staff and from the general public who appear at the hearings. The County keeps us updated with the current law and through my years of legal practice including many years of arbitration and mediation, I have sufficient knowledge of the air quality issues, arbitration and the law. Specifically with regards to engineering--my time advising the City of Las Vegas public works division and my time at the Public Service Commission--brought me in contact with many engineers and finance professionals and their work product. As a result, my education and experience qualifies me to work as a Clark County Air Pollution Control Hearing Officer.
