

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2  
DECATUR BOULEVARD  
TROPICANA AVENUE TO SAHARA AVENUE**

**THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 2** is made and entered into this 9<sup>TH</sup> day of November 2023, by and between Clark County, a political subdivision; and the City of Las Vegas, a municipal corporation; hereinafter referred to individually as “ENTITY” or collectively as “ENTITIES,” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The RTC and the ENTITIES are hereinafter referred to individually as “PARTY” or collectively as “PARTIES.”

**WITNESSETH;**

**WHEREAS**, the RTC approved Interlocal Contract 3035 dated June 9, 2022, and supplemental interlocal contract dated February 9, 2023, for Decatur Boulevard, Tropicana Avenue to Sahara Avenue, hereinafter referred to as “PROJECT,” located wholly within Clark County, Nevada; and

**WHEREAS**, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

**WHEREAS**, the ENTITIES agree to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

**WHEREAS**, the ENTITIES desire to add the City of Las Vegas, a municipal corporation; to Interlocal Contract 3035 to provide financial assistance on the PROJECT; and

**NOW, THEREFORE**, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

**SECTION III: GENERAL; shall be revised to include Paragraph 9 as follows:**

9. The COUNTY will be the lead agency for the PROJECT with the City of Las Vegas providing financial assistance; and

The remainder of Interlocal Contract 3035 dated June 9, 2022, and supplemental interlocal contract dated February 9, 2023, shall remain unchanged.
