The following are the pertinent provisions of the Contract:

- The term of the Contract is from date of award through December 31, 2023, and includes the option to renew for 4, one-year periods.
- Includes the option to increase the award amount up to 20% based on possible increased user requirements for the renewal terms and approved budget appropriations.

- Includes the option to increase the award amount up to 3% for possible price increases for renewal terms.
- Includes the County's option to terminate for cause, convenience or default and suspend the Contract with advanced written notice.
