**WHEREAS** the parties desire to amend the CONTRACT.


**NOW, THEREFORE**, the parties agree to amend the CONTRACT as follows:

**CONTRACT FOR CLARK COUNTY SOCIAL SERVICE  
BURIAL AND CREMATION FEE SCHEDULE**

- **Cremation Services**

Adult Cremation Fee	\$925
Child Cremation Fee	\$925

- **Burial Services**

Adult Burial Mortuary Fee	\$1027
Adult Burial Cemetery Fee	\$1300

\*NOTE: The cost of an oversized casket is an additional \$104

Infant Burial Mortuary Fee	\$445
Infant Burial Cemetery Fee	\$562

- **Other Services**

Body Bag Fee	\$50
After-hours Fee (Within 1 Hour)	\$60
After-hours Fee (Over 1 Hour)	\$30

**Southern Nevada Veteran's Memorial Cemetery:**

CCSS also works with the Veterans Cemetery in Boulder City to ensure eligible Veterans receive proper interment. Interment is free for the Veteran and a charge of \$450 will be incurred for the spouse of a Veteran for opening and closing of a site. If the Veteran's death is connected to a service-related disability, for which he/she received a pension, the crematory, cemetery, funeral establishment, or direct cremation facility will bill the VA directly.
