



Moapa Valley Fire Protection District Advisory Board Application

The Moapa Valley Fire Protection District (District) operates as a Volunteer Fire Department organized pursuant to NRS 474.460 and Chapter 3.20 of the Clark County Code. The District was created for the prevention and extinguishment of fires in the unincorporated areas, generally located, described, and comprising the following: From the northerly Warm Springs area, Moapa Valley, Logandale, Overton, the Valley of Fire, and southerly, including the Echo Bay area. The District operates out of three (3) separate fire stations that are all supported by local volunteers.

The District is governed by the Moapa Valley Fire Protection District Advisory Board (Board). The Board members are appointed by the Board of Fire Commissioners for a two-year (2-year) term.

There is currently a Citizen Non-Volunteer Firefighter position vacant on the Board. The position will be appointed in February 2024 and will serve a two-year (2-year) term. If you are interested in applying for the position, please complete the application below.

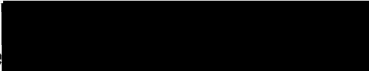
