BACKGROUND:

This ordinance approves and authorizes the issuance of the Airport System Jet Aviation Fuel Tax Refunding Revenue Bonds, Series 2022A and Las Vegas-Harry Reid International Airport Passenger Facility Charge Refunding Revenue Bonds, Series 2022B to refund the Airport System Jet Aviation Fuel Tax Refunding Revenue Bonds, Series 2013A and Airport Passenger Facility Charge Refunding Revenue Bonds 2012B both of which are callable on January 1, 2023, and July 1, 2022, respectively.

This ordinance also authorizes the redemption and early payment of all or a portion of the Airport System General Obligation Airport Bonds, Series 2008-A, Airport System Subordinate Lien Revenue Bonds, Series 2008C-2 and 2008C-3, and General Obligation Refunding Airport Bonds, Series 2013B.

The terms outlined in these agreements reflect current market conditions for these types of transactions and
