The reply was to construct an additional Type 4 manhole. This is a new item of work and a price could not be agreed upon by negotiations. The manhole will be constructed by Force Account. The estimated amount is \$40,000.00.

There is also additional cross gutter and sidewalk ADA ramps to be removed and replaced that were not indicated on the plans for which the contractor will need to be compensated. The estimated amount is \$15,000.00.
