

**SUPPLEMENTAL NO. 3 TO THE
PROFESSIONAL ENGINEERING SERVICES CONTRACT FOR
JONES BOULEVARD FROM CACTUS AVENUE TO BLUE DIAMOND ROAD**

THIS SUPPLEMENTAL NO. 3 CONTRACT, made and entered into this 18th day of January, 2022, between CLARK COUNTY, NEVADA, a political subdivision of the State of Nevada, hereinafter referred to as COUNTY and WSP USA INC., a corporation authorized to do business under the laws of the State of Nevada, hereinafter referred to as ENGINEER.

WITNESSETH

WHEREAS, on September 20, 2016, the COUNTY and the ENGINEER entered into a Professional Engineering Services Contract for Jones Boulevard between Cactus Avenue and Blue Diamond Road; and,

WHEREAS, the COUNTY and the ENGINEER entered into Supplemental No. 1 to the Professional Engineering Services Contract on January 22, 2019 for additional design engineering services, and entered into Supplemental No. 2 to the Professional Engineering Services Contract on December 1, 2020 further extending the design engineering services consisting of the performance of a pedestrian field study at Levi Avenue/Somerset Hills Avenue and related traffic design improvements, for Jones Boulevard between Cactus Avenue and Blue Diamond Road; and,

WHEREAS, a contract extension is needed for the ENGINEER to complete the Special Services, Section 2.03.

NOW, THEREFORE, for and in consideration of the premises herein contained, it is agreed to supplement the Professional Engineering Services Contract dated September 20, 2016, Supplemental No. 1 dated January 22, 2019, and Supplemental No. 2 dated December 1, 2020.

ARTICLE IV: TIME OF PERFORMANCE

Replace the last paragraph in Section 4.01 Time of Performance with the following:

Except as provided above, the ENGINEER shall complete all Basic Services and authorized Special Services by the end of December 31, 2022, unless the COUNTY amends such date.

The remainder of Section 4.01 shall remain unchanged.


