Good afternoon Judge Cruz and All,

Your request for JAG funding submitted to the Office of Criminal Justice Assistance was forwarded to the Office of Traffic Safety. After assuring that the funding is allowable under 23 CFR 1300.23, we submitted a request to NHTSA to expand your grant to cover the costs of electronic monitoring device installation, monitoring and testing as defined in your application for funding.

I am pleased to inform you that NHTSA has approved the addition to your OTS grant budget of \$86,415.

Your OTS grant [TS-2024-LVJC-00002](#) award amount has been increased from \$64,950 to \$151,365 and the budget will be revised to include support of:

• Electronic monitoring - GPS device installation	\$ 2,400
• Electronic Monitoring – GPS monitoring	22,500
• Electronic Monitoring - SCRAM CAM Alcohol Monitoring	6,030
• Electronic Monitoring – Drug Patch standard panel	350
• Electronic Monitoring – Drug Patch opioid panel	535
• Random Drug Testing – observed urinalysis	<u>64,600</u>
Total:	<b>\$86,415</b>
