

**SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1
LAUGHLIN
CASINO DRIVE, NEEDLES HIGHWAY TO HARRAH’S HOTEL**

THIS SUPPLEMENTAL INTERLOCAL CONTRACT NO. 1 is made and entered into this 10TH day of February 2022, by and between Clark County, a political subdivision, hereinafter referred to as “COUNTY” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The COUNTY and RTC are collectively referred as the “PARTIES.”

W I T N E S S E T H

WHEREAS, the RTC approved Interlocal Contract #1057 dated January 10, 2019, for Casino Drive from needles Highway to Harrah’s Hotel, hereinafter referred to as “PROJECT,” located wholly within Clark County; and

WHEREAS, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the COUNTY agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, the RTC wishes to change the funding account for the PROJECT; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

SECTION II: PROJECT COSTS; the first sentence shall be revised to read as follows:

The RTC agrees to provide funding for all costs associated with the PROJECT from the Highway Improvement Acquisition Fund.

The remainder of Interlocal Contract #1057 dated January 10, 2019, shall remain unchanged.
