

## **Agreement**

Between

Outside Las Vegas Foundation

dba Get Outdoors Nevada

and

Clark County

This Agreement sets forth the terms and understanding between the Outside Las Vegas Foundation, (OLVF), a non-profit organization doing business as Get Outdoors Nevada, (GON), and Clark County, (County), through Clark County Parks and Recreation Department, (Parks), for programming taking place during the 2022 summer season at Winchester Dondero Cultural Center.

### **Background**

GON is a local 501(c)(3) not for profit organization that works to improve community and the environment by connecting residents to Southern Nevada's special outdoor places. The County's mission is creating fulfilling opportunities for the community through diverse experiences.

As such, GON and the County agree to partner together to provide immersive, experiential, interpretive programs and experiences for youth in Clark County. These programs will teach students important safety and stewardship information in class, which will be followed by excursions to Southern Nevada's public lands. Some destinations may exist outside of Clark County. Although these programs and trips will highlight many aspects of public lands, specific objectives include:

1. Working as a group to develop team-building skills.
2. Provide an immersive hiking/exploring experience, not possible on typical field trips.
3. Promote the importance of nature conservation.
4. Promote the importance of water conservation.

### **Purpose**

This Agreement highlights the agreed responsibilities of each party.

*Outside Las Vegas Foundation, dba Get Outdoors Nevada, will:*

1. Work with the County through Parks to schedule module based programs during the months of June and July.
2. Work with Parks to secure transportation funding as necessary.
3. Provide curriculum materials and educational programs to Parks.
4. Provide one staff member to lead both the in-class and field trip portions of the program at each site.
5. Promote and recognize the County as a partner.
6. Schedule the transportation and coordinate other logistics needed for each trip if utilizing commercial transportation.

7. Provide Parks with copies of participant photos, letters, poems, journals, or other similar materials upon request. Authorization to use the above-listed materials must be obtained from the person or if a minor, from the minor's parent or custodian.
8. Provide program information and logos for promotional purposes upon request.
9. Provide an informational flyer and itinerary for each scheduled field trip to Parks.
10. Provide any classroom materials as needed to complete GON's curriculum.
11. Agree to background checks for all participating employees and/or staff members.
12. Continue to carry liability insurance with \$2 million aggregate limit and \$1million limit for each occurrence.
13. Name Clark County as a co-insured.

*Clark County will:*

1. Work with GON to schedule module based programs during the months of June, July, and August.
2. Organize and schedule the desired group of kids for the programming.
3. Provide staff to assist the GON staff members in the classroom and on field trips.
4. Schedule the transportation and other logistics needed for each trip if utilizing county transportation.
5. Promote and recognize GON as a partner.
6. Provide OLVF with copies of participant photos, classwork, journals, or other similar materials that are required by our grant reporting processes. Authorization to use the above-listed materials must be obtained from the person or if a minor, from the minor's parent or custodian.
7. Create and disperse promotional materials for GON programming as decided by both parties.
8. Handle the entire registration as well as any payment process on the part of the participants.
9. Provide and distribute field trip permission slips, photo releases, and any other waivers required.

**Duration**

This Agreement will be effective for the calendar year of 2022. However, it is restricted to the following months: June, July, and August in regards to summer programming. This Agreement may be modified by mutual consent of authorized officials from GON or the County. This Agreement shall become effective upon signature by the authorized officials from the GON and the County and will remain in effect until modified or terminated by mutual consent. Either party may terminate without cause with 14 days written notice to the other party. In the absence of modification or termination, this Agreement shall end on 12/31/2022.


