### Greetings,

My name is Melissa Perez, and I am employed by the Department of Family Services as an investigator of child abuse and neglect. Formally, my title is Senior Family Services Specialist as well as a Nevada Initial Assessment Specialist. My role requires me to utilize the SIPS model to assess for child safety. I am required to identify the underlying variable that warrants child welfare intervention. This role has given me the opportunity to take a closer look at the barriers parents are faced with. One of the barriers I commonly come across is substance use, specifically opioids. Oftentimes, parents and caregivers disclose a history of opioids such as oxycodone, hydrocodone, morphine, and methadone. Recently, there have been several parents and caregivers who have disclosed the use of fentanyl and methamphetamines. The opioid epidemic does not only impact parents; unfortunately, children under the age of 18 are also impacted.

The opioids epidemic started to increase in 1999; however, there was a drug epidemic prior to opioids that should also be discussed concurrently when addressing the current barriers. The cocaine/crack epidemic was an epidemic that dramatically increased the foster care system from 400,000 in 1900 to 567,000 in 1999. Unfortunately, this epidemic ripped families' apart, especially families of primarily African American decent. To ensure that the opioids epidemic is addressed correctly, it is important to also highlight the cocaine and crack epidemic. It is also important to implement any successful programs that were developed as a result.

My interest in joining the opioids task force stems from a desire to ensure that adequate and supportive services are developed. As well as ensuring that services are diversified to accommodate all cultures and socioeconomic backgrounds. Like the cocaine and crack epidemic the opioids crisis continues to place vulnerable children in foster care.

I believe that my cultural sensitivity and awareness qualifies me to be on the task force as my interest would be in the those that are having a difficult time combatting this epidemic on their own.
