**BACKGROUND:**

On September 15, 2020, the Board of County Commissioners (Board) approved the award of RFQ No. 605480-19 for Emergency Shelter to Catholic Charities of Southern Nevada (NBE), Hopelink of Southern Nevada (NBE), and Las Vegas Rescue Mission (NBE) in the aggregate amount of \$41,992,830.68 to provide emergency shelter and support for households that are experiencing homelessness.

The following are the pertinent provisions of the Contracts:

- The term of the Contracts was from date of award through June 30, 2022 and included the option to renew for 3, one-year periods and included a 6-month extension.
- Included the County's option to terminate for cause, convenience or default and suspend the Contract with advanced written notice.

Amendment No. 1 with Catholic Charities of Southern Nevada extended the Contract term through June 30, 2025.

Amendment No. 1 with Hopelink of Southern Nevada and Las Vegas Rescue Mission, and Amendment No. 2 with Catholic Charities of Southern Nevada extended the Contract term through June 30, 2026.

Approval of Amendment No. 2 with Las Vegas Rescue Mission and Amendment No. 3 with Catholic Charities of Southern Nevada will extend the Contract term through December 31, 2026, or until the new RFQ is awarded, whichever occurs first. The attached Amendment No. 2 with Las Vegas Rescue Mission and Amendment No. 3 with Catholic Charities of Southern Nevada document details the modifications and costs involved.

Both firms are in compliance with Clark County Business License requirements.
