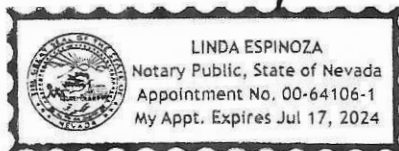

**NOTIFICATION OF PROPOSED AMENDMENT TO CLARK COUNTY
CODE TITLE 7, CHAPTER 7.200 (NEW) – SIDEWALK VENDORS; AND
TITLE 18, CHAPTER 18.03 – SIDEWALK VENDOR (DELETED)**

Dear Licensee and Community Partners:

Pursuant to NRS 237.080, please be notified of proposed amendments to Clark County Code, Title 7, Chapter 7.200 (new), for Sidewalk Vendors, and Title 18, Chapter 18.03, for Sidewalk Vendor (deleted). The amendments are available for your review online at www.clarkcountynv.gov/depts/businesslicense.

Specifically, the proposed amendments will add a new chapter to Title 7 for Sidewalk Vendors. The proposed amendments address the following key areas:

- **Section 7.200.010** establishes findings regarding sidewalk vendors.
- **Section 7.200.020** defines terms used in this chapter.
- **Section 7.200.030** clarifies that this new chapter does not apply to businesses operating under and in compliance with Chapter 6.130 – Mobile Food Vendors.
- **Section 7.200.040** requires anyone operating a sidewalk vending business to obtain a county business license.
- **Section 7.200.050** establishes application requirements for a sidewalk vendor business license.
- **Section 7.200.060** requires each sidewalk vendor business to maintain a general liability insurance policy.
- **Section 7.200.070** establishes a limit on the size and number of conveyances that a sidewalk vendor may operate at any one time.
- **Section 7.200.080** requires each sidewalk vendor to obtain and maintain a valid permit from the Southern Nevada Health District.
- **Section 7.200.090** outlines the provisions for issuance or denial of a business license.
- **Section 7.200.100** prohibits the transfer or assignment of a sidewalk vendor license.
- **Section 7.200.110** establishes requirements for a change in ownership of a licensed sidewalk vendor business.
- **Section 7.200.120** establishes an annual license fee of \$150.00.
- **Section 7.200.130** requires licensee to conform to applicable laws and to cooperate with personnel from regulatory agencies.
- **Section 7.200.140** identifies the duties of the licensee.
- **Section 7.200.150** provides that the provisions in Chapter 7.200 of the Clark County Code and NRS Chapter 244 does not exempt a person from complying with state and local laws and regulations and does not provide a defense for any criminal charge.
- **Section 7.200.160** provides operating requirements for sidewalk vendors.
- **Section 7.200.170** prohibits certain acts for sidewalk vendors.
- **Section 7.200.180** sets limitations on hours of operation for sidewalk vendors.
- **Section 7.200.190** sets limitations on locations of operation for sidewalk vendors.
- **Section 7.200.200** provides that the provisions of this chapter do not affect the rights of a private property owner to use, or authorize or limit the use of a sidewalk that is owned by the private property owner.
- **Section 7.200.210** provides for enforcement actions and penalties for violations.
- **Section 7.200.220** provides for the revocation, suspension, condition, limitation or non renewal of a license for noncompliance.
- **Section 7.200.230** provides for the destruction and disposal of unauthorized food that has been cooked, prepared or unsealed from the original packaging by a sidewalk vendor that does not possess a valid permit issued by the Health District.

The proposed amendments also delete **Chapter 18.03** on Sidewalk Vending in its entirety to prevent redundancy with provisions that have been relocated and clarified in Clark County Code, Title 7, Chapter 7.200 (new).

In accordance with NRS 237.080, business owners and interested parties may submit data and arguments to the Clark County Board of Commissioners, in care of the Department of Business License as to whether the proposed amendment will:

1. Impose a direct and significant economic burden upon a business; or
2. Directly restrict the formation, operation or expansion of a business.
