INTERLOCAL FOR FACILITY USE LICENSE AGREEMENT

This Amendment No. 1 to the **License Agreement** is made by and between the BOARD OF REGENTS OF THE NEVADA SYSTEM OF HIGHER EDUCATION, ON BEHALF OF THE UNIVERSITY OF NEVADA, LAS VEGAS (“**Licensor**”) and CLARK COUNTY, NEVADA (“**Licensee**”), herein identified individually as a “**Party**” and collectively as the “**Parties.**”

WHEREAS, on December 23, 2021, the Parties entered into a License Agreement for vaccinations services at UNLV Paradise Campus; and

WHEREAS, due to the demand for COVID-19 testing the Parties have agreed to move the location of the COVID-19 testing and vaccinations to Sam Boyd Stadium located at 7000 East Russell Road, Las Vegas, Nevada 89122.

NOW, THEREFORE, for good and valuable consideration, the Parties hereby agree to amend the License Agreement as follows:

1. The parties agree that the term “Property in Section 1.0 of the License Agreement shall be amended to read:

The term “**Property**” whenever used herein, means, Sam Boyd Stadium located on parcel numbers 162-26-801-001 and 162-35-501-001, as described in in **Amendment Exhibit “A-1,”** which is attached hereto and incorporated herein by this reference.

2. The Parties agree that the term “**Vaccination**” in Section 4.1 shall include providing COVID-19 vaccinations and COVID-19 testing services.

3. The revisions contained herein are effective as of January 9, 2022.

Except as expressly amended in this Amendment 1, the License Agreement shall remain in full force and effect.
