**AMENDMENT NO. 1

**THIS AMENDMENT** is made and entered into this \_\_\_\_ day of \_\_\_\_\_ 2024, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and HOWMEDICA OSTEONICS CORP DBA STRYKER SALES, LLC (hereinafter referred to as "PROVIDER").

**WITNESSETH:**

**WHEREAS** the parties entered into an agreement under CBE Number 606586-23, entitled "EMS CPR Machine" dated June 26, 2024 (hereinafter referred to as CONTRACT); and

**WHEREAS** the parties desire to amend the CONTRACT.

**NOW, THEREFORE**, the parties agree to amend the CONTRACT as follows:

1. Section II-A, Page 1, Compensation.

**ORIGINALLY WRITTEN:**

COUNTY agrees to pay PROVIDER for the PRODUCT described in the Price List (Exhibit A) in accordance with the fees therein for the not-to-exceed amount of **\$990,000**. COUNTY'S obligation to pay PROVIDER cannot exceed the not-to-exceed amount. It is expressly understood that the Price List defined in Exhibit A must be completed by PROVIDER and it shall be PROVIDER'S responsibility to ensure that PRODUCT are properly budgeted.

**REVISED TO READ:**

COUNTY agrees to pay PROVIDER for the PRODUCT described in the Price List (Exhibit A) in accordance with the fees therein for the not-to-exceed amount of **\$2,990,000**. COUNTY'S obligation to pay PROVIDER cannot exceed the not-to-exceed amount. It is expressly understood that the Price List defined in Exhibit A must be completed by PROVIDER and it shall be PROVIDER'S responsibility to ensure that PRODUCT are properly budgeted.

This Amendment No. 1 represents an increase of \$2,000,000.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
