**AMENDMENT NO. 5

CRISIS STABILIZATION AND SUPPORTIVE HOUSING
CONTINUITY OF CARE PROGRAM**

THIS AMENDMENT is made and entered into this ____ day of _____, 20____, by and between CLARK COUNTY, NEVADA (hereinafter referred to as "COUNTY"), and CHARLESTON RESIDENTIAL SERVICES LLC dba CROSSROADS OF SOUTHERN NEVADA (hereinafter referred to as "PROVIDER").

WITNESSETH:

WHEREAS the parties entered into an agreement under RFQ Number 605240-19, entitled "Crisis Stabilization and Supportive Housing Continuity of Care Program" dated December 12, 2019 (hereinafter referred to as CONTRACT); and

WHEREAS the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. SECTION I: TERM OF CONTRACT, as revised per Amendment No. 4:

ORIGINALLY READ:

COUNTY agrees to retain PROVIDER for the period from date of award through December 31, 2020 with the option to renew for four (4), one-year periods subject to the provisions of Sections II and VIII herein. During this period, PROVIDER agrees to provide services as required by COUNTY within the scope of this Contract. COUNTY reserves the right to extend the Contract for up to an additional twelve (12) months on a month-to-month basis for its convenience.

REVISED TO READ:

COUNTY agrees to retain PROVIDER for the period from date of award through December 31, 2025. COUNTY reserves the right to extend the Contract on a month-to-month basis through October 31, 2026.

2. The revisions contained herein are effective as of January 1, 2026.

This Amendment No. 5 represents an increase of \$4,122,661.55.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.
