#### **QUARTERLY OVERVIEW**

During the third quarter of the 2024 Fiscal Year (January 2023 – March 2024), Real Property Management Design & Construction (RPM D&C) has continued to successfully utilize the Job Order Contract program for project implementation and delivery. The program continues a steady workflow, and the job order process is operating effectively. The JOC contractors have continued to complete and close out projects over the reporting period. The ability to strategically identify FY24 capital projects has continued to help schedule and organize Job Orders in an efficient and manageable manner. RPM D&C has processed through a significant amount of project backlog and newer FY24 projects in this quarter.

During this reporting period RPM D&C added thirteen (13) new Job Orders/Supplemental Job Orders to the program, successfully awarded eleven (11) new Job Order Authorizations (JOA's) and advanced fifteen (15) JOA's into the construction phase. Additionally, a total of forty-six (46) Job Orders (individual projects) have been completed to date and are closed out, or in the process of being closed out.

### **COST SUMMARY**

Current data collected for the for the Job Order Contracting program shows that construction costs continue to level out as a more diverse project mix is added to the program. When blended across all projects, costs are showing 10-12% lower than RPM's anticipated budget amounts for the original Job Order scope. As the program progresses and more projects are executed, RPM D&C is realizing cost savings in the areas of professional service fees that would have been spent to create contract bid documents for a competitive bid. These cost savings are helping to offset the construction proposals under the JOC program and helping to hold the overall budget of the projects. RPM D&C can utilize the budgeted design portion of the project budget to offset the higher rates for construction work proposals. This design or planning work typically gets wrapped into the JOC contractors' scope where they hire the professional services directly to produce design and permit drawings. RPM D&C is realizing a benefit of faster project execution with more accurate scope development and less construction delays due to contractor participation in the project development. This "premium" in cost has a direct correlation to a "best value" delivery method and is benefiting the County with shorter project durations and less issues during construction.

#### **SCHEDULE SUMMARY**

On average, current job orders are taking 13.5 weeks to develop, approve and receive a purchase order, and approximately 16-weeks to complete the work for a total of 29.5 weeks or ~7 months. These timelines have increased by approximately 2 months over the last quarter. This timeframe is indicative of the increased value and types of projects being added to the program for this reporting cycle. The 29.5-week timeframe remains faster than the 24-30 months needed for the typical Design-Bid-Build process and has allowed RPM D&C to execute quickly on a wide range of project types. The JOC program timelines continue to allow RPM D&C to maintain a healthy project backlog and execute quicker on new incoming projects. RPM D&C and its staff continue to see benefits of faster and less cumbersome project delivery under the Job Order Contracting program.
