

Second Amendment to Lease Agreement Between Boys & Girls Club and Clark County

SECOND AMENDMENT TO LEASE AGREEMENT BETWEEN BOYS & GIRLS CLUB AND CLARK COUNTY

This Second Amendment to the Lease Agreement ("Second Amendment") is made and entered into this _____ day of _____, 2026 by and between CLARK COUNTY, a political subdivision of the State of Nevada (hereinafter "COUNTY" or "Lessor") and the Boys and Girls Club of the Colorado River ("BGC" or "Lessee"), individually a "Party" and collectively the "Parties".

WHEREAS, BGC entered into a Lease Agreement with the COUNTY on April 16th, 1996, and First Amendment, dated September 1, 2020 (collectively, the "Lease"), for +/- 1,419 square feet of office space for exclusive use and +/- 2,639 square feet of office and +/- 944 square feet of patio space for non-exclusive use owned by the COUNTY, within a portion of the building known as the Spirit Mountain Activity Center, located at 1975 Arie Avenue, Laughlin, NV 89029, Assessor's Parcel Number 264-21-601-002; and

WHEREAS, NRS 244.284 authorizes the Clark County Board of Commissioners ("Board") to lease any of the real property of Clark County not otherwise needed for public purposes to a non-profit corporation recognized as exempt under Section 501(c)(3) of the Internal Revenue Code for charitable or civic purposes on such terms and conditions as the Board deems appropriate; and

WHEREAS, COUNTY and BGC desire to modify the Lease upon the terms and conditions hereinafter set forth.

NOW, THEREFORE in consideration of the promises and mutual covenants and agreements herein contained, the Parties agree the Lease shall be amended as follows:

1. SECTION 1 AND ATTACHMENT A OF THE LEASE, DATED APRIL 16, 1996, SHALL BE DELETED AND REPLACED WITH THE FOLLOWING:

"1. DESCRIPTION OF PREMISES. Lessor is the owner of 2610 Needles Highway, Laughlin, NV 89029 Assessor's Parcel Number 264-21-601-002 ("Property") as depicted on Exhibit A, which houses the Spirit Mountain Activity Center with the physical address of 1975 Arie Avenue, Laughlin, NV 89029 ("Building"). Lessor hereby leases to Lessee exclusive use of space within the Building in rooms #111 (RECEPT.), #112 (OFFICE), #116 (COMPUTER ROOM), #119 (KITCHEN), and #120 (PANTRY) for a total of +/-845 square feet ("Exclusive Space"), shared use of space within rooms #113 (MEN), #114 (WOMEN), #115 (TEEN ROOM), #117 (STORAGE), #118 (REC ROOM), AND #132 (COOR) for a total of +/-2,639 square feet ("Shared Space"), the Exclusive Space and Shared Space are collectively, the "Premises". The Premises are further defined and depicted on the attached Exhibit B."

2. **NO OTHER MODIFICATION.** Except as modified in this Second Amendment, all other terms and conditions of the Lease shall remain unchanged and in full force and effect. To the extent of a conflict between the terms of the Lease and the terms of this Second Amendment, the terms of this Second Amendment shall prevail. A breach by BGC of any of the terms of this Second Amendment shall constitute a material breach by BGC of the Lease as to which COUNTY shall have all rights and remedies. This Second Amendment may be executed in multiple counterparts, each of which shall be deemed to be an original, but all of which, together, shall constitute one and the same instrument.

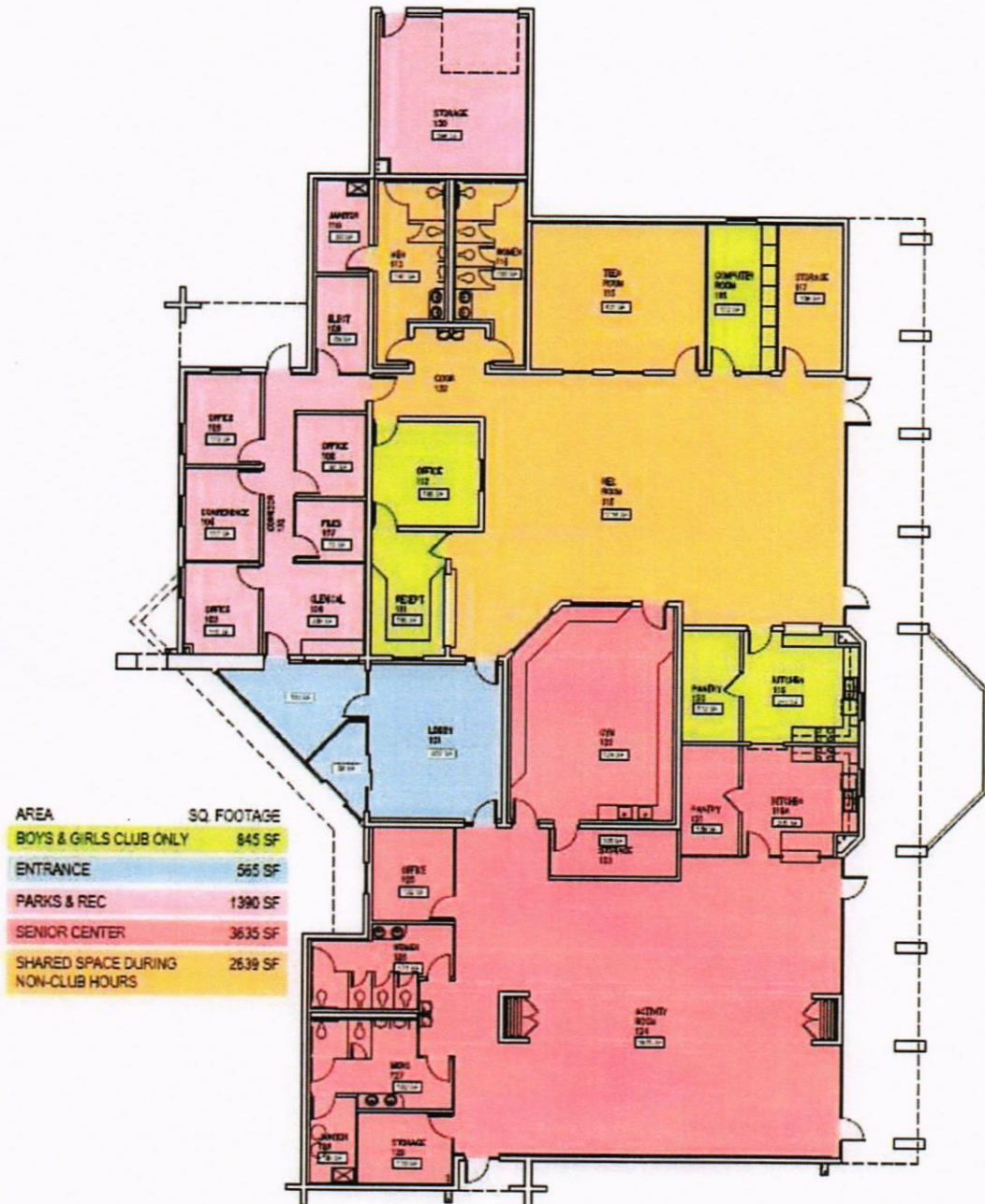
