Letter of Interest: Maureen Strohm, MD, FAAFP, DFASAM

To the Selection Committee for the Opioid Task Force:

It would be an honor to serve on the Opioid Task Force and address and support efforts to improve the care of patients and families across Nevada who are impacted by substance use disorders.

Over my career as a board-certified family physician (continuously certified since 1981) and addiction medicine physician (certified through ABAM in 2012, and ABPM certified since 2022), I have been engaged in developing program enhancements and new programs and areas of emphasis with a focus on addiction medicine. As a faculty member at the Keck USC School of Medicine and program director for a family medicine residency in downtown Los Angeles, I implemented various activities to increase knowledge and skills for physicians to identify and address the needs of patients and families impacted by substance use disorders. This has included participating in advocacy efforts along with the resident physicians-in-training, including participation in Advocacy Days at the state level.

Over the years, I have been an active member of the American Society of Addiction Medicine (ASAM) and California Society of Addiction Medicine (CSAM), and have been teaching faculty for the CSAM Annual Conference since the 1990s with a yearlong Scholars program to promote addiction teaching and clinical care in residency programs throughout the US. Here in Nevada, I have worked to formally establish the Nevada Society of Addiction Medicine to bring professionals across multiple disciplines together to increase the focus on evidence-based treatments across all sites of care – from primary care practices, addiction treatment programs and specialized addiction medicine practices. As an example, recent national surveys demonstrate that only 30% of patients discharged from addiction treatment centers receive life-saving medication assisted treatments in combination with necessary psychosocial treatments. That translates to 70% of patients are discharged at risk for relapse, overdose and death – with higher rates within the first few weeks and months following discharge.

We must do better for our patients and our communities!

Since coming to Nevada, I have designed and achieved accreditation for a new family medicine residency at Southern Hills Hospital, implementing a required rotation in addiction medicine to include both immersive and clinical experience including harm reduction. In 2020, our Addiction Medicine Fellowship was granted accreditation by the Accreditation Council for Graduate Medical Education (ACGME), the accrediting body for residency and fellowship training programs. Due to COVID-19 concerns regarding impact on clinical services,

we postponed our inaugural class to 2021 and are now training our 3rd class of fellows.

As part of my responsibilities as program director, I was able to negotiate for several training sites to build a community-based network of addiction programs, methadone centers, correctional facilities, the inpatient psychiatric services at Southern Hills Hospital, and the VA Southern Nevada Health Systems for a robust experience with management of detoxification, medical management of patients with various substance use disorders and, and experience with the range of psychological and behavioral therapies. We have implemented longitudinal training which includes community outreach and harm reduction experiences. Faculty who support the fellowship program and fellows, include Dr. Lesley Dickson who has been a leader in Nevada and nationally regarding efforts to expand care and services for patients and families with SUDs. She has been key in promoting the importance of advocacy for our fellows and other faculty. Dr. Elliot Wade has provided fellows' experience in the correctional system, promoting the evidence-based care of individuals in the carceral system with life-changing and life-saving medications. Our first fellow, Dr. Jose Partida Corona, is now on faculty and supervises fellows in his primary care/addiction medicine practice as they follow a panel of patients with substance use disorders, primarily opioid use disorder.

In addition, I have been a member of the Public Health Commission of the Nevada State Medical Association, as well as a member of the Nevada Hospital Association's Nevada Bridge Pilot Program over the past 2 years, working to implement strategies for screening, brief intervention and initiation of medication treatment (specifically buprenorphine or naltrexone) in the emergency rooms and hospital services in our Las Vegas hospitals. Efforts to promote buprenorphine treatment for individuals with opioid withdrawal or following overdose and resuscitation must be accelerated and we are beginning to see these changes in some of our emergency rooms. Harm reduction at the hospital level in shifting as well with efforts to dispense or prescribe naloxone for patients on opioid prescriptions and especially for those with opioid use disorder.

It is with this background of skills and my commitment to lifelong service, that I believe I am well suited to serve on this new Opioid Task Force. We can provide better care for all Nevadans – from prevention and harm reduction services to high quality, evidence-based care for those impacted by the various substance use disorders.

I look forward to hearing your decision ... to welcome me to this new Opioid Task Force.
