

**AMENDMENT NO. #1

FORENSIC DRUG TESTING**

THIS AMENDMENT is made and entered into this ____ day of _____ 2023, by and between CLARK COUNTY, NEVADA (hereinafter referred to as “COUNTY”), and SOBER TESTING SERVICES, LLC (hereinafter referred to as “PROVIDER”).

WITNESSETH:

WHEREAS, the parties entered into an agreement under CBE Number 606243-22, entitled “FORENSIC DRUG TESTING” dated August 11, 2022 (hereinafter referred to as CONTRACT); and

WHEREAS, the parties desire to amend the CONTRACT.

NOW, THEREFORE, the parties agree to amend the CONTRACT as follows:

1. Add the following to Section XII: Miscellaneous as Letter T, Price Adjustment Requests

T. Price Adjustment Requests

Commencing on date of award, prices shall not be subject to change during the initial Contract term, thereafter, there may be price adjustments. All price adjustment requests, including suitable proof, shall be submitted, at least thirty (30) calendar days in advance of PROVIDER’S expectation of price increase commencement, to the Clark County, Nevada, Administrative Services Department, Purchasing Manager, 500 South Grand Central Parkway, Las Vegas, Nevada 89155. Price increases shall not be retroactive. A price adjustment can only occur if PROVIDER has been notified in writing of COUNTY’S approval of the new Price(s). Only one (1) written price adjustment request(s) will be accepted from PROVIDER per renewal term. The reference months/period and indexes to be used to determine price adjustments will be the most recent published index between 14-16 months prior (using the final index) and 2-4 months prior (using the first-published index) to the anniversary date of the Contract, using the price index specified below.

Consumer Price Index (CPI): All Urban Consumer, U.S. city average. Series ID: CUSR0000SA0 will be used as the index for the price adjustments. The price adjustment per year may be the lesser of the percent of CPI or PPI change or six (6) percent for an increase or decrease.

- Suitable Proof:

Print-out of CPI/PPI index and calculated increase.

- Drastic Market Conditions

Should drastic market conditions occur which dictate a significant price increase of any line item(s) during the term of Contract, COUNTY may consider these increases in addition to the allowed increases, providing PROVIDER submits written documentation and suitable proof by line item to COUNTY requesting permission and explaining in detail the unforeseen circumstances predicated the request to increase pricing. Suitable proof shall be required as defined above. A significant price increase means a change in price from the date of the last price increase, to the date of performance by an amount exceeding six (6) percent. General industry correspondence with regards to market conditions are not suitable proof.

2. Replace EXHIBIT A, Scope of Work in its entirety, with attached hereto.

Except as expressly amended herein, the terms and conditions of the CONTRACT shall remain in full force and effect.

**EXHIBIT A
FORENSIC DRUG TESTING
SCOPE OF SERVICES**

The pricing for drug testing to be conducted by Sober Testing Services (STS) is \$15 per test for any combination of 10 drugs from the "Standard Drugs of Abuse" assay list. Each additional drug from the Standard Drugs of Abuse list will be charged an additional \$1.00 per drug requested, up to \$21 per test for all 16 drugs offered. Client may request additional specialty drug types be added to testing protocol, depending on availability of reagent by Contractor. These drugs will be listed as Specialty Drugs of Abuse and Contractor will provide cost per test in writing. Currently STS offers four Specialty Drugs of Abuse as listed below. The cost of a full panel test that includes all Standard Drugs of Abuse and all Specialty Drugs of Abuse would be \$27. All tests will include Creatinine for validity purposes.

Every test includes:

- Access to testing randomizer
- Specimen collection
- Analysis through Chemical Analyzer (Mindray BA-800M)
- Electronic reporting through Drug Court Case Management (DCCM) within 48 hours. Email reporting can be requested in addition.
- View only account to Paracelsus for agency results and reporting
- Storage of all "Positive" samples for 30 days from collection

**LAB
CONFIRMATION/VALIDATION**

The contractor will use a nationally certified laboratory to conduct Liquid Chromatography –Mass Spectrometry (LC-MS) for all confirmations requested by the client. Contractor will only be responsible for confirmation on positive samples identified by the Contractor’s lab, and only upon request of the client or sample provider. A lab confirmation fee will be assessed per drug being confirmed, as outlined below. The fee must be paid by the individual or the client must authorize payment to be included in monthly invoicing prior to the sample being sent to the lab.

Confirmations require the contractor to package the sample, maintaining chain of custody protocols, and mail to the contracted lab. Time frames for confirmation results vary based on variables outside of the Contractor’s control but all efforts will be made to have results reported to the Client within 7 business days from the request for confirmation.

Storage of Samples

All positive samples will be maintained by the Contractor in accordance with all legal chain of custody requirements for a period of 30 days. If a sample is sent to the national laboratory for confirmation, the laboratory will maintain the sample for an additional 30 days. Samples older than 30 days will not be accepted by the nationally certified laboratory for confirmation testing.
