Approve and authorize the increase in total available funding for the grease trap/interceptor grant program to support the cost of installing new grease traps in Commercial Center from \$150,000 to \$500,000; increase to the not to exceed amount per grant from \$25,000 to \$90,000, and authorize the Director of Operations to execute grease trap grant agreements and any necessary documents associated with implementing the grant program. Approve and authorize the Chair to sign the First amendment to the Interlocal Agreement between Clark County Redevelopment Agency and UNLV College of Fine Arts for an increase of \$50,000 to the total sponsorship amount; and to include coverage for of Ancillary Provisions supporting the five pilot projects. Approve the purchase of 925 East Sahara Avenue Buildings D & F located on Assessor's Parcel Numbers 162-10-512-003 through 073 which consist of two (2) two-story retail/office buildings containing a gross building square footage of 84,320 on +/- 1.03 acres of land; fund the purchase price of \$5,000,000, \$10,000 for closing costs and \$1,316,724 for construction development; ratify the appraisal dated January 11, 2024 by Colliers International Valuation & Advisory Services; and Authorize the Director of Operations to sign escrow documents and any other related documents to complete the transaction and management of the leases.
