- YOLANDA KING So, Madam Chair, Item Number One on your agenda for today is public comment.
- MARILYN KIRKPATRICK 'kay, this is the first time set aside for public comment on any Items on our agenda. If I could just ask that - when you come forward to speak, please state and spell your name for the record. Please, no clapping and everybody will have three minutes. And I have approximately thirty-five cards so - we will go through the process. I'm not going to - so - I'm not gonna call your names cause I don't wanna misspell anybody's names but you can just line up at the podium and what I'll do is - I'll go through the cards as I see you and then - if I miss anybody, I'll - do a final call for anybody that would like to speak, so good morning Miss Coleman. It's almost afternoon.
- MARGARET ANN COLEMAN Yes, good afternoon Commissioners; I stayed due to the fact of having more to say. One of the items you have is o - overdose - recognition. You guys have created this epidemic of overdose approving we for the I's. The psychotic drug for the mind of controlling the feelings but mainly the brain just to open up that brain center across the street. That is an illegal tactic. As you know Thirteen Sixteen a Wizard is rightfully mize cause I paid for it. Two thousand and one to two thousand and seven only this land ends a property, so that - that redevelopment in which Shanta Mulhughes - I mean -- taken from me and now you guys have placed Shanta Coleman in control and not giving me my respect as a family member with the same last name. KIRKPATRICK Thank you, Miss Coleman. Next speaker, please. If you could state and spell your name for the record, that'd be great.

GINA GIAMBRA Does my three minutes start before my name or after?

GIAMBRA Okay. Hello, my name is Gina Giambra, G-I-A-M-B-R-A I'd like to start off by saying God bless America, and our Constitution and freedoms. I'm gonna go fast here so. Addressing or ca calling a public meeting to the Metropolitan Police Department and Joe Lombardo as soon as possible. Addressing a call for public hearing to actually get answers from questions we ask you, the panel. Addressing every time, we have come in here to oppose items. These items are still getting passed. Please explain this to us GIAMBRA

peons. Addressing how many of you are being paid to sign off on items that go against Nevada's constitution, the U.S. Constitution and what we the people oppose. Addressing voting machines and hackers switching votes. We know some of you weren't elected but still got your position. In the next elec - election here, we already know it's going to be violated because of what's going on in California. We know that you guys follow California's lead oh dark lord Sisolak. KIRKPATRICK Okay, thank you. Next speaker, please.

JAMES BUTLER JR J-A-M-E-S B-U-T-L-E-R Junior I stopped asking myself why that you guys act the way you do and the School District too, the School Board, I stopped ask - you guys are obviously being paid by somebody else. You're being pa - not by the United - you're gettin' something on the side. Everybody realizes this. We're all sick of this stuff. This is communism and you know it. I didn't - I'm - I wonder, did we sign up for this stuff through the secret applications on these phones? Did we sign up for communism somehow because that's the attitude we're getting? Like, we already signed up for this s*** and it's already over. I'd like to know; did we sign up communism through hidden contracts with the Chinese on these phones? Did we sign up for hidden contracts? I mean, I'm tellin' ya, because this seems like you - it's - it's flat.

BUTLER JR There's no life in you people. It's like we're already screwed. I rejected the computer up until like three years ago because my kid was giving my problems at school. So, I rejected that s***. You know what? I feel so happy today. I'm not brainwashed. Youse are sold out. There's nothing else. The School District, they don't look at - nobody looks at nobody. I wanna know who's payin' your bills? Who's - who's payin' your bills, that's what I ask you. You know it's bull****, you do.

KIRKPATRICK Thank you. Next speaker, please.

MINDY ROBINSON It's Mindy Robinson M-I-N-D-Y R-O-B-I-N-S-O-N I'm here because my commissioner Justin Jones wants to label free speech as a public safety crisis to quote unquote take any action deemed appropriate toward it - to fight vaccine misinformation. Like you have that right at all. Let's talk about who's really spreading misinformation here. So, every post you do online about the vaccine will be flagged as safe. Except there are no long-term studies, there's no generational side effects, the shortterm side effects are pretty debilitating and fatal, and all the animals died during testing. Does that sound safe to you? Last week, Rolling Stone did an article where injured people were getting turned away from the hospital cause there were so many Ivermectin overdoses. That entire story was false. No cases like that existed there and the doctor they quoted didn't even work there. Speaking of Ivermectin, Fauci doesn't want to recommend it but do you wanna know what he did recommend? Remdesivir. Based on a whole study of one person. What he failed to mention was that it was cut short because it has a fifty-four percent mortality rate. One third of the people were getting kidney and organ failure and dying. This is all online if you really look for it and get off Google. First off, discussing the side effects of an experimental injection is not a danger to our democracy. We are not a democracy. Democracy is mob-rule. We are a constitutional republic. And the Constitution protects us from people like you coming in and taking our property, our rights, and our freedom. You are pushing people to fight for their lives, their children, their country. Do you think we're just gonna give it up because you just do whatever the hell you want? Because you've got a socialist on your Board because you've got people who don't care about the constitution even though it's in your job requirements. You've gotta decide what side you're gonna be on in history. You wanna be the side of right? You wanna be on the side that's poisoning everybody? Just remember, you're gonna have to face us when you leave your houses and when you go out cause we're gonna be here. We're waitin' for you.

Magaliene Eyard E-N-Y-A-R-D and first of all, I'd like to say that I feel it's very important all of us got to come together in peace and - pray that we can solve anything thats go on. Because everything happens for a reason alright, and it wouldn't happen, and everybody is not involved in the reason whether it's bad or good. Everybody's not involved. And I've seen some - bad reasons in - neighborhoods, very very dirty. And - I like to comment on Las Vegas Boulevard, one of the worst streets, to me, named after the city, Las Vegas. Somebody is in for it for that, not being upkept - abandoned buildings. Graffiti all over

ENYARD everywhere. Just ridiculous for a street named after the city. Then I walk through other sss streets, like Charleston, Martin Luther King. Now if dirt - I mean not just put there, it's been there for years. And even the - orange cement border across the street from this building, it's orange in color, I live behind it. Whoever put that up four feet, whatever, behind it, they did not pick up the trash. They just put it in front of the trash, and you can go see yourself. I saw that and I think that's ridiculous but everybody on the Board, everybody in community cannot be in fault of that. That got to fall on certain people. And that should be straightened out because like I say, everything happens for a reason whether it's a good reason or a bad reason. And we need to straighten out these reasons, to be honest Okay, thank you.

KIRKPATRICK Thank you. Next speaker, please.

My name is Kelly Adkison, for the record. KELLY ADKISON That's A-D-K-I-S-O-N. Well, we know you guys don't listen to facts. We know don't listen to your Nevada constituents. We know you don't follow science. So the truth is, I'm not here to do any of those things. I'm here to redo a Notice of Maladministration. We're submitting two today. One regarding Number Ninety-Six and one regarding Number Sixty-Six agenda items. Notice to agent is notice to principal and notice to principal is notice to agent, whereas your sworn oaths of office con - constitutes a contract with the people of Nevada. As bonded trustees involuntary indentured servants, it is your duty to carry out the wishes of the people that granted authority for you to handle the peoples' business. When you violate your oath, you've committed a breach of contract. Whereas the people have the absolute right to regulate their internal government and are guaranteed the right to reform, alter, or abolish government whenever the public good may require it. Article One, Section Two of the Nevada Constitution, when you ignore the peoples' grievances, you've committed a breach of trust.

ADKISON

Whereas regarding Agenda Item Ninety-Six, the free exercise and enjointment of religious profession and worship without discrimination or preference shall forever be allowed in this state. And no person shall be rendered incompetent to be a witness on account of his opinions on matters of his religious belief. But the liberty of conscience hereby secured shall not be so construed as to excuse acts of licen - licentiousness, hard tough word, or justify practices inconsistent with the peace or safety of this state. Article One, Section Four of the Nevada Constitution licentiousness is the indulgence of the arbitrary will of the individual without regard to ethics or law or respect for the rights of others such as Agenda Item Ninety-Six. The resolution of censorship, whereas every citizen may freely speak, write, and publish his sentiments on all subjects being responsible for the abuse of that right and no laws shall be passed to restrain or abridge liberty of speech or of the press. Article One, Section Nine of the Nevada Constitution. Agenda Item Ninety-Six is a resolution of censorship. The people shall have the right to freely - have the right freely to assemble together to consult for a common good, to instruct their representatives, and to petition the Legislature for address of grievances. Censuring the people's right to assemble, consult, in instruct and redress their grievances is a violation of Article One, Sections Nine and Ten of the Nevada Constitution and the first amendment of the Constitution of the United States of America.

BONNIE MCDANIEL Good morning, my name is Bonnie McDaniel. I am not a public speaker. I - I'm a sixty-two-year resident of Las Vegas and a forty-year open heart and head trauma nurse. Masks are more harm and do more harm to people than they do good. MCDANIEL

This is such a bad look for you. To even put this, you know, on the agenda to say hey, we're going to discuss having health information - health misinformation be a public health crisis. And then take any action deemed appropriate? I mean, I don't know if you realize the optics of how this sounds. It sounds so bad. It sounds so draconian. It sounds so Unamerican. And this is the type of thing that we all notice. We all notice this. We're here, we're reading it. People in Nevada care about this stuff and we're not having it. So, private discussions about COVID are always gonna happen. My background is in engineering and in central finance. I've spent my career in higher education and my wife is an ICU nurse. And, I had COVID. Obviously, it's - it's a real disease and I still, you know, cannot taste substantially what I used to. But, you know, science, you know math, physics, biology, chemistry are perfect, but our understanding of those scientific disciplines is not perfect. And then our application, you know of providing vaccines, trying to have a scientific remedy to COVID is even worse. And, you know, I'm all for science, that's what I've spent my background

in, I work in that, but, you know, I don't appreciate only having one narrative. It's -It's not acceptable, it's not okay. You know, my wife sees things in the hospital and my other friends in the medical field here in Las Vegas, they say all the time, I've got a patient, he just came in. You know, twenty-six-year-old male, bilateral pulmonary embolism, and a look in the chart and he'll have, you know, Pfizer or Modera two weeks earlier. And the hospital administration will say bury it, just bury it. And these are the types of things that, you know, we're talking about and you can't limit that type of conversation and so, of course, there is an official narrative that the government is trying to put out and there's an agenda behind it and I don't know what orders are being passed down to you but I'm saying, that, you know, we want to have a great Board of Commissioners. And we want to have a Board of Commissioners that's responsive to what Nevadan what - what Nevadans are seeking and wanting. And, this is just completely in the opposite spirit, you know, and it just sounds like such a punishment. You know, that - that, they would be considered a public health crisis. So, our understanding, if anybody claims that they're understanding of COVID is perfect, they're a total liar. Not only am I an American citizen, forty-eight years strong, I'm also an intelligent, awakened citizen with common sense. Being an American citizen is not only in my mind, it is in my NASTAV

heart and in my soul of which you have no access or governing right to. What does this mean? It means I'm an American patriot. But most importantly, it means I'm not afraid of the likes of you. Good afternoon ladies and gentlemen. My name is FRANCES DEANE Frances Deane and I apologize for showing up here looking like this today. I wasn't gonna come but then I started hearing the same old, repetitive masks er, and freedom of speech and shots and whatever trans - forming humans are. I want to remind you, Marilyn, maybe you remember, Justin, you look a little young, Tick, you'll remember the babies that were born with little arms and little legs. Some of them died. There called the thamaldihide babies. For five years, from Nineteen Fifty-Seven to Nineteen Sixty-Two, the federal government and Europe, and the United States gave these pills for morning sickness to mothers that caused growth deformities to their babies. And you don't - you don't do that so why should we sit here and put our masks on when you don't

KIRKPATRICK You already had your chance, anybody has not spoken, please-

UNIDENTIFIED It's on the agenda-

- KIRKPATRICK Please ma'am. Mister Uehling go ahead. Come one.
- UNIDENTIFIED (UNINTELLIGIBLE)
- KIRKPATRICK Mister Uehling, did you want to speak? Mister Uehling, please. Let him in, please. Go ahead sir.

ED UEHLING Yes, - my - my name is Ed Uehling. I just find it incredible that - that -we're - we're actually considering that the government should be the one - arbit - arbit - arbiter of the truth? It's just - it's just beyond belief that we can even be thinking about that. Let's just start with - with the basics. Everyone blames the pandemic for what happened. Ju - listen to the rhetoric. Everyone - the pandemic did this, the pandemic caused that. No, the pandemic caused the death of people that are old and who have - imm - immune compro - immune compromise systems. That's what the - that's what the pandemic does. The shutdown is the disaster UEHLING

that has occurred in - in Clark County, in Nevada, in the United States. The - an -and we don't say that. It's - it's the shutdown that for example, four hundred school age children in the entire United States have died from COVID. Even - even with the fake statistics that are coming out. Fa - four hundred school age children. Out of what, a population of eighty million? And - last year, seventeen - four hundred children in the United States translates to four children in Nevada. Nevada has one percent of the population of the country. So, four children in Nevada perhaps - schoolchildren died. Seventeen children committed suicide last year. In two thousand nineteen, only one child committed suicide. That's due, not to the pandemic. The pandemic didn't kill them. The shutdown of our political leaders killed killed - killed these people. - KIRKPATRICK Thank you, Mister Uehling. Any anyone else that hasn't spoke, please come forward now, okay.
- DANIEL BRAISTED Good afternoon. Daniel Braisted, resident of the City of Las Vegas - again on item ninety-six. The thing to understand about science is that it's complicated. Physics is not. Physics, we can get to Mars and back cause the laws are there. But science is so complicated because of your emotions. If I take a medical - tablet today but I have certain emotions, then it will react differently than somebody else. My heredity, my environments, what my mind is

saying so - it - it's I'm asking you to reconsider this - item. I presented pictures about live and blood - analysis at a past meeting and never heard any comments from it. I mentioned that - the future of medicine is the medicine of - of frequencies. And I quoted Einstein. And this is the device that I'm using. This used to be a mainframe with the Russians, and they - they helped to keep their astronauts up in the nineteen eighties. It's now shrunk down to this. What this can do is phenomenal. Yet, if you're interested, let me know. I invited about sixty individuals in government to the Alternative Medical Conference at the Westgate about a month ago. And as far as I know, nobody attended that I recognized. Now, this is a group of people that are seeing medicine differently. They're talking about frequencies. KIRKPATRICK Anyone else wishing to speak. Please no clapping. Okay, let's go next speaker, please. Come on.

JOHN CARLO Can you give me some space, please?

KIRKPATRICK

Yep, come on. Come right to the center and you'll have plenty of space. Come on. Go ahead. Please state and spell your name for the record.

John Carlo may be running for office when I know JOHN CARLO these machines are working right. I'm here in the name of the great Governor of the universe, the Lord Jesus Christ. I quote to you one of the ten commandments which was in some of y'alls schoolrooms when you were growing up. Exodus Chapter Twenty, Verse Sixteen. Thou shall not bear false witness against thy neighbor. Let me - interpret is for you. Bearing false witness doesn't mean that you lie.
