AMENDMENT I TO INTERLOCAL AGREEMENT BETWEEN CITY OF NORTH LAS VEGAS AND CLARK COUNTY, NEVADA CRAIG RANCH PARK TRAIN PROJECT

THIS AMENDMENT I TO INTERLOCAL AGREEMENT ("Amendment I"), by and between the City of North Las Vegas, a municipal corporation of the State of Nevada ("City") and Clark County, Nevada, a political subdivision of the state of Nevada ("County"), and individually and collectively referred herein as the "Party" and "Parties", respectively, is effective on the later of the date ("Effective Date") approved by the Board of County Commissioners ("BCC") or the City of North Las Vegas ("City"), as long as approval by one is within thirty (30) days of approval by the other.

RECITALS

WHEREAS, on February 19, 2020, the Parties entered into an Interlocal Agreement ("Agreement") for the City to install a miniature train at Craig Ranch Regional Park and the County agreed to provide funding for a portion the construction cost for the Project (as defined in the Agreement); and

WHEREAS, Nevada Revised Statute ("*NRS*") 277.180 provides that one or more public agencies may enter into contracts for the performance of desired services; and

WHEREAS, due to supply chain issues being experienced throughout the construction industry, the City cannot complete the Project by December 31, 2021 and is requesting an extension of time to complete the Project; and

NOW, THEREFORE, for and in consideration of the promises and mutual covenants herein contained, it is agreed the terms below shall be amended as follows:

The Parties agree to amend the following provisions of the Agreement:

- A. Article II Section 16. Delete December 31, 2021 and replace with June 30, 2022.
- B. Article III Section 1. Delete December 31, 2021 and replace with June 30, 2022.
- C. Exhibit B. Delete "Two covered passenger loading platforms" and replace with "One (1) covered passenger loading platform." Also, remove the requirement for the City to construct one "Train Storage Barn" with workshop and storage containers.
- D. Exhibit B. Add the following provision:

The City at the City's sole expense will construct one (1) "Train Storage Barn" with workshop and storage containers by December 31, 2022.

E. This Amendment I may be executed in counterparts, all such counterparts will constitute the same Amendment I and the signature of any Party to any counterpart will be deemed a signature to, and may be appended to, any other counterpart. Executed copies hereof may be delivered by facsimile or e-mail and upon receipt will be deemed originals and binding upon the Parties hereto, regardless of whether originals are delivered thereafter.
